## SHARE AUCTIONING RESULTS OF DONG NAI BRICK AND TILE CORPORATION AND BINH DUONG WATER SUPPLY SEWERAGE ENVORONMENT LIMITED COMPANY

On August 10<sup>th,</sup> 1,227,800 shares of Dong Nai Brick and Tile Corporation hold by Building Materials Corporation No 1 – Company Limited and 17,634,200 shares of Binh Duong Water Supply Sewerage Environment Limited Company were offered to the public at Hochiminh Stock Exchange.

Dong Nai Brick and Tile Corporation (TUILDONAI), formerly Dong Nai Brick and Tile Factory, went into operation since 1952 and was transferred ownership to the State after April 30 th, 1975. The company specializes in producing and trading building materials from clay including bricks, tiles, ceramic and etc. At the end of the auction, 1,203,000 shares were sold to 7 individual investors at the average



price of VND 15,202,000, raising more than VND 18 billion.

On the same day, in the IPO of Binh Duong Water Supply Sewerage Environment Limited Company (BIWASE) at HOSE, 283 investors (269 domestic individuals, 9 domestic institutions and 5 foreign institutions) had placed 61.9 million shares, 3.5 times



higher than total shares offered. The final results showed that all of shares offered were sold out to 36 individuals and 5 institutions at the average price of VND 14,277,000, raising more than VND 251 billion.

Binh Duong Water Supply Sewerage Environment Limited Company, originally "Binh Duong Water Supply Center", was changed the name and transformed to Limited Company model in 2005. BIWASE operates in water supply; industrial waste treatment; building and investing in drainage system and hydro power project; and etc. According to the equitization plan, after IPO, the State continues holding 51% of company's charter capital (76.5 million shares), 2.24% (3.4 million shares) are held by the employees, strategic investors hold 35% (52.5 million shares) and the public holds the remaining 11.76% (17.6 million shares).
