3. Changes:

- i. The remaining amount of VNECO Son Tra Project worth VND11,514,055,464 was temporarily added into the working capital. According to the resolution of annual general meeting 2017 dated 03/24/2017, the Board of Directors was authorized to seek a partner to transfer this project.
- ii. The remaining amount of Green Mart Project worth VND20,000,000,000 was added into the working capital. The general meeting of shareholders on June 03, 2016 decided not to execute this project and authorized the BoD to transfer this project.
- iii. The Company raised its working capital by VND36,364,420,000 from the proceeds of public offering. And, it also used VND20,000,000,000 from Green Mart Project. Besides, the Company temporarily used VND11,514,055,464 of VNECO Son Tra Project for its working capital.
