## AUCTION RESULTS OF THU DUC TOURIST, PHU THO TOURIST, CIENCO 5 AND CIENCO 6

On 31<sup>th</sup> December 2015. 4 share auctions of Thu Duc Tourist Co., ltd, Phu Tho Tourist Co., ltd, Civil Engineering Construction Coporation No 5 (JSC) (Cienco 5), Civil Engineering Construction Coporation No 6 (JSC) (Cienco 6), were conducted on Hochiminh Stock Exchange.



Phu Tho Tourist and Thu Duc Tourist are limited companies operating in the tourism and hospitality industry. In the auctions, Phu Tho Tourist offered 30,264,420 shares, representing 25.5% stake at the offering price of 12,000 VND/share while Thu Duc Tourist offered 3,293,888 shares which equivalent to 25.5 % charter capital at offering price of 10,000 VND/share.



Meanwhile, Cienco 5 and Cienco 6 are infrastructure leading construction Corporations which belong to Ministry of Transport, performing in building roads & bridges, irrigation, hydroelectric plant; investment in new town, industrial zone; reconnaissance, design & consult about transportation, civil and industrial works. In the auctions, Cienco 5 offered 10.176.000 shares in batch which equivalent to 23.18% charter capital at the offering

price of 101,861,760,000 VND while Cienco 6 offered 45,695,000 shares in batch, accounting for 92.88% charter capital at the offering price of 457,452,645,000 VND.

At the end of the auctions, Thu Duc Tourist sold 5,600 shares 3 for individual raising investors, 57,500,000 VND. Phu Tho Tourist, Cienco 5, Cienco 6 sold out all of offered their shares. raising 373 billion VND, 202 billion VND, 457 billion **VND** respectively.



The share auctions of Cienco 5 and Cienco 6 are the first share auctions in batch conducted on Hochiminh Stock Exchange according to the Decision No. 41/2015/QĐ-TTg dated September 15<sup>th</sup>, 2015 of the Prime Minister. Details of four above auctions are as following tables:
