On amendment to some contents of the Decision No. 510/QĐ-EVNCHP-HĐQT dated December 14th 2017 of the Board of Directors approving feasibility study of Cu Jut Solar PV Power Project, Dak Nong province

Pursuant to the Construction Ministry's Circular No.18/2016/TT-BXD of 30 June 2016 detailing and guiding a number of contents on project appraisal and approval, design and cost estimates of construction works;

Pursuant to the Charter of Central Hydropower Joint Stock Company (EVNCHP);

Pursuant to the Regulation on operation of the Board of Directors (BOD) of the Company;

Pursuant to Decision No. 510/QĐ-EVNCHP-HĐQT dated December 14th 2017 of the Board of Directors approving feasibility study;

Pursuant to Decision No. 521/QĐ-EVNCHP-HĐQT dated January 18th 2018 of the Board of Directors of EVNCHP approving contractor selection plan of Cu Jut Solar PV Power Project, Dak Nong province;

Pursuant to the Resolution No. 5/2018/NQ-EVNCHP-HDQT dated May 15th 2018.

DECIDED

Article 1. To amend the Decision No. 510/QĐ-EVNCHP-HĐQT dated December 14th 2017 of the Board of Directors with the following contents:

1. Amendment to item 9 of Article 1:

"Administrative building and residential building for staff: i) Type of works: Construction work code No. 2.1.2; (ii) Grade: Grade IV.

Fences, gate and guard house: i) Type of works: Structural construction work, small scale code No.2.14.1; (ii) Grade: Grade IV".

are amended to:

"Administrative building: i) Type of works: Construction work code No. 2.1.2; (ii) Grade: Grade III.

Residential building for staff, warehouse, guard house, water tank: i) Type of works: Construction work code No. 2.1.2; (ii) Grade: Grade IV.

Fences: i) Type of works: Structural construction work, small scale code No.2.14; (ii) Grade: Grade IV".

2. Supplement to item 9 of Article 1:

Drainage channel: i) Type of works: Construction work code No. 1.5.1.1; (ii) Grade: Grade IV.

3. Supplement to item 10 of Article 1: "Design of solar power under the EPC package is 3-step design".

Article 2. The General Director of Central Hydropower Joint Stock Company is assigned to implement the examination, review and approval of amendments to technical design, construction drawing design and cost estimates relating to changes and amendments to the Decision No. 510/QĐ-EVNCHP-HĐQT dated December 14th 2017 of the Board of Directors as the contents mentioned in the Article 1.

Article 3. Members of the Board of Directors, the Supervisory Board and the General Director of Central Hydropower Joint Stock Company are responsible for implementing this decision.
