- Board Member Mr. Hideaki Takase, Mr. Yotaro Agari: Non-residential Board Member, attend (i) some BoD's monthly meetings and (ii) give written opinions of the BoD.
- Resolution of the 2018 Annual General Meeting of Shareholders No. 18/NQ-ĐHĐCĐ dated 21/4/2018 approved the amendment and supplementation of VietinBank's Regulation on the Organization and Operation of VietinBank BoD, accordingly, the standing BoD no longer existed.

2. Supervision by the BoD over the Board of Management (BoM):

Supervisory activities of the BoD over the BoM are carried out in accordance with the internal management regulations, the regulations on organization and operation of the BoD and the regulation on organization and operation of the BoM. On the other hand, the CEO is also a board member, thus ensuring the supervision of the BoD on management activities.

At regular monthly meetings of the BoD, the CEO reported all aspects of VietinBank operations as well as the results of implementing AGM and BoD's resolutions.

In addition to periodical reports, for the first half of 2018, the CEO on behalf of the BoM also reported to the BoD several topics for further discussion, such as:

- Government's Resolutions, Directives and Circulars of the State Bank of Vietnam (SBV) on measures to manage monetary policy, stabilize interest rates & macro-economy and restructure of banking sector, such as Resolution No.01 of the Government on major tasks and solutions to direct the implementation of the socio-economic development plan and state budget estimates in 2018; The SBV's active and flexible monetary policy aiming to stabilize macro balances and control inflation, support economic growth at a reasonable level; The scheme "Restructuring the system of credit institutions associated with dealing with bad debts in the period 2016-2020" and Resolution No. 42/2017 / QH14 piloting bad debts resolution of credit institutions...;
- Global economic developments, volatility in the global stock market and impact on Vietnam's macro economy as well as banking activity;
- Risk management, progress of implementing Basel II, operation control and debt quality control, bad debts resolution plan;
- Progress of implementing major IT projects of VietinBank;
- Network development, stepping up the standardization of the organization model, consolidating and reforming the organizational structure and operation model with the roadmap towards international standards....

The BoD also assigned the BoM to closely monitor the macroeconomic situation & market developments to flexibly carry out the set - out key tasks, in order to accomplish the 2018 business plan, thus marking the 30 years anniversary of development of VietinBank.

For 1H2018, VietinBank's business operation still enjoyed stable growth. As compared to 31/12/2017, total assets at the end of June 2018 were estimated at 1,140 trillion VND, up over 40 trillion VND, an increase of 4% as of year-end 2017; credit growth were estimated at 7,56%, higher than that of the banking industry (6,84%). In which, outstanding loans were projected to increase by

9.8% as compared to beginning of the year. Efficiency targets were maintained as planned, consolidated ROA and ROE were estimated at 1% and 13%, respectively.

With the above results, VietinBank continues to maintain and improve the credit rating and development outlook according to international credit rating agencies in 1H2018 and was honored the awards and accolades from domestic and international institutions such as 6th time in Top 2000 largest enterprises in the world; 6th time in Top 500 World's Most Valuable Banking Brands with a brand value of \$ 381 million, an increase of 51,3% as compared to 2017, brand strength AA; The 14th time at the leading Top of Strong Brand in Vietnam; Top 10 Best VNR 500...

During period 2018 – 2020, VietinBank's orientation is to develop in-depth, sustainable growth associated with business efficiency; To improve the income structure and increase the proportion of non-interest income, especially the revenue from services through comprehensive promotion of product and service quality; to develop payment banking activities, catching up with the trend of non-cash payment and industrial revolution 4.0; to raise financial capacity for stable and safe development; to improve labor productivity through improving operational efficiency, streamlined processes and effective cost management through improving resource allocation and operational cost control.

3. Activities of the BoD's committees:

At present, VietinBank has 02 committees under the BoD namely Nomination, Salary and Reward Committee and Risk Management Committee. The Committees operate in accordance with the Regulation on organization and operation of each Committee issued by the Board, specifically:

- Nomination, Salary and Reward Committee: advising the Board on the organizational structure, personnel management policies, performance evaluation and treatment policies; assisting the Board in re-evaluating personnel within the decision-making authority of the Board; Organizing comprehensive supervision and control of personnel management, capacity framework, succession planning, human resources risk in line with business orientations and plans of VietinBank in each period.
- Risk Management Committee: Advising the Board on issues related to the determination of risk appetite in each period based on practical situation and market development; Formulating risk management mechanisms, policies and orientation on managing credit risk, investment risk, market risk, operation risk and other types of risks; Advising the Board on approval of investment, related transactions, management policies, risk handling plans within the scope of functions and tasks assigned by the BoD.

In 1H2018, the Committees continued to work with relevant departments to review, finalize, amend and promulgate new regulations, procedures on risk management, personnel, reward,...; Advising and proposing to the BoD about risk management strategies and policies, risk prevention measures on various aspects, implementing initiatives to implement Basel II according to the roadmap; review the personnel under the management of the Board to contribute to improving the capacity and quality in personnel management; Proposing and advising the Board on strategic planning and development of VietinBank in the coming time....

2. Surveillance activities of the Supervisory Board toward the BoD, BoM and shareholders:

In 1H2018, the Supervisory Board has implemented the tasks and functions in accordance with law, VietinBank's Charter as well as the regulations on the organization and operation of the Supervisory Board, which was approved by 2018's AGM, specifically:

2.1. Supervising business operations, compliance with law and Charter in management and administration of VietinBank; implementing AGM's resolutions.

In 1H2018, the Supervisory Board carried out monitoring activities through the following contents:

i. Periodically monitor, update information on business activities of VietinBank, participate and exchange opinions at BoD, BoM's meetings:

Every month, representatives of the Supervisory Board attended all BoD and BoM meetings to capture information. At BoD meetings, the Supervisory Board presented monitoring report and provided independent opinions and views on outstanding issues, potential risks in business operations, management and administration of VietinBank as well as giving recommendations to the BoD and BoM. Comments of the Supervisory Board have been recorded in monthly Minutes of Meeting.

ii. Review of policy documents, BoD's resolutions/decisions:

The Supervisory Board has assigned one member to review policy documents issued by the BoD & the CEO and BoD's resolutions/decisions being sent to the Supervisory Board. After reviewing, the Supervisory Board found that, the policy documents, BoD's resolutions/decisions are basically in accordance with law, VietinBank's Charter and meet the requirements of governance & management of VietinBank that follows the mission assigned by the AGM.

iii. Review the monitoring reports, audit reports of internal audit department:

Based on monthly reports on main business activities of VietinBank and reporting on the internal audits of all subjects/units in the system as planned or unexpectedly by the internal audit department, the material issues identified through monitoring and auditing as well as recommendations and proposals from internal auditors are reported to the Board at regular meetings, The internal audit reports shall also be sent directly to the Chairman of the Board of Directors and the General Director.

iv. Regarding collecting, analyzing, evaluating data, figures and recommendations related to business activities:

In 1H2018, in implementation of specific work programs and plans assigned on a case by case, members of the Supervisory Board collected, analyzed and evaluated data and figures related to the business activities of VietinBank, from which written proposals were submitted to the Chairman and General Director.

2.2. Appraisal of financial statements

Performing the functions and duties stipulated in VietinBank's Charter, the regulation on the organization and operation of the Supervisory Board, in 1H2018, the financial statement appraisal team has been set up to review the financial statements for 2017. The results of the examination have been sent to the BoD, BoM timely to seek approval at the AGM as well as making disclosure in accordance with law.

2.3. Updating list of related people

The updating list of related persons of BoD, BoM and Supervisory Board's members as well as shareholders holding at least 5% of voting shares at VietinBank have been periodically done by the Supervisory Board on the basis of coordination, exchange information with the Board's Secretariat. The results of monitoring and updating show that, compared to 2017, the list of related persons of VietinBank in 1H2018 has some changes due to the change of BoD member who are representive of strategic partner MUFG Bank.

2.4. Direction and supervision of internal audit's operations

In 1H2018, the Supervisory Board regularly instructed internal audit department to implement its functions and tasks as regulated by the SBV and VietinBank, and deployed the approved audit plan. At the same time, the Supervisory Board reviewed the reports as well as evaluation of performance results of the internal audit department at the regular meetings of the Supervisory Board. The audit results, together with recommendations of the internal audit department were promptly sent to the BoD, the CEO as well as the related departments.

3. The coordination among the Supervisory Board with the BoDs, BoM and different managers:

During the implementation of the supervisory role, the Supervisory Board actively coordinated with the BoD, the BoM and other managers through recommendations and direct discussions at regular or extraordinary meetings or by written petition for each specific case. In 1H2018, the coordination between the Supervisory Board and the BoD, the BoM and other managers was smoothly implemented in accordance with law and internal regulations of VietinBank.

4. Other activities of the Supervisory Board:

In 1H2018, besides performing main functions as regulated by law, VietinBank's Charter and internal regulations, the Supervisory Board directly instructed and joined with internal audit department to implement the coordination, support activities for external inspection and auditing authorities at VietinBank.

IV. Training on corporate governance in 1H2018:
