HOCHIMINH STOCK EXCHANGE WELCOMES THE FIRST TRADING DAY OF VIETNAM INTERNATIONAL COMMERCIAL JOINT STOCK BANK (VIB)



On 10th November 2020, Hochiminh Stock Exchange (HOSE) organised a ceremony to celebrate the listing of Vietnam International Commercial Joint Stock Bank (Stock Code: **VIB**). There were **924,491,395** shares listed on the exchange worth more than VND 9,244 billion. The reference price on the first trading day was VND **32,300** per share with a price range of +/- 20%.

Vietnam International Commercial Joint Stock Bank (VIB) was established in 1996 with the initial charter capital of VND 50 billion. After several capital increased, the charter capital has increased 185 times compared with the first day of establishment, reaching VND 9,245 billion. The core services of VIB include capital mobilization, credit, foreign currency trading and payment, debt purchase, securities investment and long-term investment.

According to the Consolidated Financial Statements of VIB, in 2018 and 2019, the total income from all business activities reached more than VND 6,085 billion and VND

8,152 billion, with after-tax profit are more than VND 2,193 billion and VND 3,266 billion, respectively. In the first 6 months of 2020, the total income from business activities is more than VND 4,814 billion, corresponding to the after-tax profit more than VND 1,885 billion.

HOSE is one of the operators of Vietnam's stock market. As of 30th October 2020, there were 386 shares, 3 closed-fund certificates, 6 ETF fund certificates, 118 covered warrant codes and 40 corporate bonds listed on HOSE. HOSE's market capitalization reached VND 3.29 quadrillion, accounting for 93% of the total national market capitalization and approximately 44.6% of the 2019 estimated GDP (nominal GDP at current prices after re-calculation).
