3. BOM Oversight of the Executive Board

The BOM of the Corporation regularly oversees the activities of the CEO and other management personnel in performing their assigned duties and responsibilities, based on the Corporation's Charter of Organization and Operation and the Regulations on the Organization and Operation of the Corporation's BOM. The BOM refrains from direct intervention in the CEO's operational duties, supporting the CEO in effectively implementing resolutions and decisions from the General Meeting of Shareholders and the BOM.

3.1. Oversight in 2024

In 2024, geopolitical instabilities caused unpredictable fluctuations in global oil prices, with significant increases and decreases, including a deep decline in Q3. Domestic demand for petroleum products dropped due to the impact of storms, particularly Typhoon Yagi (Typhoon No. 3) and flooding in northern regions. The sharp increase in USD exchange rates raised financial costs due to exchange rate differences, negatively affecting the corporation's business performance.

In this context, the BOM closely monitored the Corporation's activities and market developments, issued appropriate directives, and supported the Executive Board in the operation of production and business activities:

- **Production and Business:** Direct, urge, and supervise the implementation of the 2024 production and business plan based on effective market analysis and forecasting; Adopt proactive and flexible sourcing strategies, actively work with the two domestic oil refineries, and seek additional domestic and import sources to ensure supply for the system and market stability; Leverage competitive advantages through the integrated chain of raw material procurement, production, storage, transportation, and distribution in crude oil and petroleum products with units in the Vietnam Oil and Gas Group; Devise responses to market fluctuations and the impacts of Typhoon No. 3 (Yagi); Seize and capitalize on development opportunities to increase business volumes, expand market share, and optimize the efficiency of petroleum terminal systems.

- **Financial Management and Debt Oversight:** (i) Direct and supervise to ensure the financial health and safety of the PVOIL system, mobilize and utilize funds appropriately, manage cash flow efficiently, ensure liquidity, and enhance the effectiveness

of capital usage to preserve and grow shareholders' investments; (ii) Strengthen debt management to prevent new bad debts, focus on recovering outstanding and difficult-to-collect debts; (iii) Direct enhanced cost management, cost-saving initiatives, and waste prevention; (iv) Supervise and assess the effectiveness of external investment activities; (v) Review and evaluate the performance of units under special supervision to determine whether to add them to or remove them from the special supervision list.

- **Investment and Construction:** Direct, supervise, and accelerate the implementation of 2024 investment projects, including: Investment/development/transfer of petrol stations; Construction and expansion of petroleum terminals; Expand, upgrade, and renovate/replace infrastructure at petroleum terminals; Construct facilities for production and business operations; Install automatic fire alarm systems at units; Pursue initiatives to seek investment opportunities for rest stops along highways and long-haul truck stops; Focus on completing projects carried over from 2023; Review and restructure the layout of the warehouse and port system across PVOIL to reduce costs and improve efficiency; Promote research and prepare documentation to obtain a license from the Ministry of Industry and Trade for Jet A1 aviation fuel trading.

- **IT Applications and Digital Transformation:** Continue to direct and accelerate the comprehensive adoption of IT, automation, and digital transformation across all production and business areas, including: Upgrade management software systems (B2B, PVOIL Easy, PVOIL 4U, etc.); Develop purchasing/sales/terminal operation modules; Build a centralized data warehouse and intelligent analytics reports; Upgrade crude oil business information management systems; Develop human resource management software; Upgrade IT infrastructure to support production and business activities; Implement the PVOIL petrol station modernization project; Advance research and develop the 2024–2030 digital transformation strategy and ERP.

- **Organizational Structure, Labor, and Salary:** Direct personnel-related matters under the BOM's authority, innovate and improve the organizational structure of member units (establish branches, add functional departments, appoint personnel to the BOM/Board of Members/Board of Supervisors at units); Direct the development and approval of staffing, labor, and salary plans for 2024, along with the 2023 salary fund finalization for the corporation and its subsidiaries.

- **Corporate Governance:** Continue to review, amend, supplement, and refine internal policies and regulations to align with current laws, decrees, and state directives, as well as the corporation's actual conditions; Enhance customer service quality at petrol stations and major petroleum terminals; Direct the review, standardization, and improvement of measurement and sales tools to establish a foundation for digital transformation, e-invoice issuance, and improved retail management at petrol stations; Direct the implementation of subsequent network security and information safety solutions following previous cybersecurity incidents; Strengthen system management and promote scientific research and IT application in management and operations to boost performance;

Enhance fire prevention, occupational safety, and hygiene, particularly at petrol terminals and stations.

- **Enterprise Restructuring and Innovation:** Continue to direct the implementation of the 2020–2025 PVOIL restructuring plan, which includes the following: restructure the parent company, organize/reorganize member units, restructure biofuel plants and complete the equitization settlement process, issue and monitor the implementation of resolutions related to the merging of PVOIL Tay Ninh into PVOIL Saigon, invest in the purchase of shares from external shareholders to convert PVOIL Binh Thuan into a single-member limited liability company; Continue to oversee the divestment process at PVOIL Cambodia; Monitor the implementation of resolutions approving the operational direction of PVOIL Laos and PVOIL Laos Trading; Maintain close coordination with the Group/Ministry of Industry and Trade/State Capital Management Committee to stay updated, report, and provide additional explanations as requested regarding the equitization settlement process.

- **Completion of Legal Documentation for Land and Attached Assets:** Direct the system to focus on reviewing and completing legal documentation for assets related to land and structures attached to land.

- **Biofuel Projects:** Continue collaboration with shareholders of BSR-BF, OBF, and PVB to implement solutions for biofuel projects as directed by authorities and in compliance with legal procedures; Regularly update information on these projects and report to relevant authorities as required.

- **Inspection and Supervision:** Monitor business operations of system units through reports from representatives at subsidiaries, periodic inspection reports from the Internal Controller Division, quarterly financial supervision reports from the Executive Board, and quarterly financial statement appraisal reports from the Corporation's Board of Supervisors. Pay attention to and direct support and remedial plans for units facing difficulties or accumulated losses, as well as units under special supervision; Direct the implementation of solutions to resolve issues identified by internal and external inspection teams; Enhance direct supervision by the BOM over the activities of system units.

- **Development Orientation and Strategic Planning:** Continue to direct alignment with the petroleum industry's development orientation and the actual energy transition context to revise and adapt PVOIL's strategies and business plans as needed; Continue to promote business cooperation and value chain integration with units under the Vietnam Oil and Gas Group, research and propose new forms of cooperation and value chains to optimize business efficiency; Explore and initiate new businesses/products using the extensive network of PVOIL retail stations and terminals nationwide (e.g., partner with VinFast/V-Green to install and operate EV charging stations at retail outlets, establish rest stop models, collaborate with beverage/snack chains, and develop a network for collecting used cooking oil); Seek collaboration opportunities with domestic and international partners to foster and expand business operations.

- **Corporate Communication and Culture:** Direct and monitor the effective implementation of internal and public communication tasks and corporate culture initiatives; Work effectively with media agencies to build a communication network promoting PVOIL's operations, products, and services; Proactively provide accurate and objective information to media agencies; Regularly monitor and promptly address any communication issues arising from incidents or misinformation by media outlets, ensuring that any incorrect or incomplete coverage of PVOIL is corrected; Prevent media crises from occurring. Strictly adhere to regulations for the unified and consistent management and use of Petrovietnam's brand identity; Continue the implementation of Petrovietnam's cultural regeneration initiative at PVOIL. The PVOIL brand is increasingly expanding its "coverage" and enhancing its brand value.

- **Coordination Efforts:** Maintain close and effective collaboration between the Board of Supervisors and the Executive Board in implementing resolutions of the General Meeting of Shareholders and the BOM. In order to strengthen the coordination of activities, the BOM directed the development of regulations on coordination between the BOM, CEO and the Board of Supervisors. The BOM supervised compliance with laws and internal regulations in managing and operating the Corporation. Resolutions/decisions issued by the BOM were promptly sent to the CEO and notified to the Board of Supervisors. The implementation of resolutions/decisions of the BOM was regularly monitored, periodically reviewed and evaluated.

3.2. Supervision Results

- The Board of Directors effectively and fully performed the assigned functions and tasks, managing the production and business operations of the Corporation in line with the goals and directions set by the General Meeting of Shareholders and the BOM.

- The Corporation met and exceeded the business and production targets for 2024 set by the General Meeting of Shareholders.

- The Corporation efficiently implemented the supply chain linking raw materials, production, storage, transportation, and distribution in the crude oil and oil products sector, in collaboration with other units in the oil and gas industry. Frequent meetings and exchanges with BSR and PVNDB were held to share market information, coordinate reporting and working with state regulatory agencies on oil and gas business, manage product flow to ensure continuous and stable operation of refineries, and maintain adequate product supplies for the Corporation's system. Efforts to closely monitor the market and oil price fluctuations helped maintain a reasonable inventory, minimizing risks and ensuring effective business operations during significant oil price drops.

- The investment and development of petrol stations through various forms was strengthened and achieved positive results during the year.

- The restructuring of member units continued as scheduled, with the units successfully merged or transformed into single-member limited liability companies quickly stabilizing their organizations, focusing on business activities, and achieving good results.

- Digital transformation, ERP implementation, and the use of 4.0 technology were strongly promoted, enhancing management and competitiveness through projects such as 1114 and 808, vocational skills competitions, and the PVOIL Easy, PVOIL B2B, and PVOIL 4U services. Security, safety, fire and explosion prevention, and counterterrorism measures were ensured, with a tightening of network security;

- Efforts to expand the scope of new product sales based on the extensive network of petrol stations and terminals across the country were made, actively seeking partners and forms of cooperation to implement non-oil services and begin the Jet A1 aviation fuel business.

- Social and community activities, including charity and welfare work, were actively implemented throughout the system, with many meaningful initiatives.

- According to the November 2024 issue of Forbes, PVOIL's brand was honored in the top 25 leading brands in Vietnam, valued at 105 million USD. Additionally, PVOIL is ranked among the top 500 largest companies in Southeast Asia according to Fortune.

- Overall, in terms of management and operation of activities within the Corporation, the CEO and management staff complied with relevant legal regulations; followed the functions and tasks outlined in the Corporation's Charter and internal governance regulations; fully and seriously implemented the resolutions and decisions of the General Meeting of Shareholders and the BOM concerning business plans and restructuring; led the Corporation's activities in line with the approved directions; and strictly adhered to the regulations on public company information disclosure, with the achievement of very promising business results for the year 2024.

4. Activities of the Subcommittees Under the BOM

The BOM did not establish any subcommittees but organized the Internal Controller Division under its direct supervision. Its role is to advise and assist the BOM in the inspection, auditing, and monitoring of the system's operations.




In 2024, the Board of Supervisors organized meetings to implement its 2024 operational plan and reassign tasks to individual members. These tasks included supervising member units and monitoring the implementation of the 2024 production and business plans of the Corporation and its subsidiaries.

3. Supervision Activities of the Board of Supervisors toward the BOM, CEO, and Shareholders

3.1. Activities of the Board of Management

- The BOM implemented resolutions from the General Meeting of Shareholders and held numerous meetings, including 12 recorded meetings, issuing 98 resolutions and decisions to manage and direct the Corporation's business activities.

- The BOM fulfilled its duties and responsibilities under the Law on Enterprises and the Corporation's Charter, regularly guiding and supervising the Executive Board's adherence to the resolutions and decisions of the General Meeting of Shareholders and the Board of Management.

- The BOM convened meetings to gather written opinions for decision-making. The BOM frequently held discussions to clarify recommendations from the Executive Board and issued resolutions and decisions accordingly.

3.2. Activities of the CEO

The CEO actively sought solutions to overcome obstacles in the Corporation's production, business, and investment activities to ensure that the Corporation achieved and surpassed the 2024 business targets.

Maintain close cooperation with units within the Petrovietnam Group to optimize the supply chain (raw materials, production, storage, and distribution) for crude oil and petroleum products, contributing to the Corporation's overall efficiency in 2024.

The CEO focused on expanding the retail network in 2024. In addition, PVOIL proactively adapted to the energy transition by collaborating with Vinfast to install electric charging stations at fuel stations, maximizing existing infrastructure. The CEO promoted the implementation of investment procedures for the Ba Ngoi Fuel Terminal, expand the Phu Tho Fuel Terminal, Nghi Son Fuel Terminal Phase 2... and accelerate the implementation of IT applications to support management and operations. At the same time, review and report on unresolved projects to the BOM.

The CEO actively implemented the restructuring plan as directed by the BOM, including reorganizing subsidiaries for the 2020–2025 period, converting PVOIL Binh Thuan into a one-member LLC, and completing the merger of PVOIL Saigon and PVOIL Tay Ninh.

The CEO regularly supported and facilitated the activities of the Board of Supervisors.

3.3. For Shareholders

The Board of Supervisors adhered to its approved operational plan from the General Meeting of Shareholders and was prepared to conduct inspections and provide explanations

as required by shareholders or shareholder groups under Clause 2, Article 115 of the Law on Enterprises. At the General Meeting of Shareholders, the Board of Supervisors reported on required content and provided observations, evaluations, and recommendations to improve governance, inspection, and oversight at the Corporation.

The Board of Supervisors collaborated closely with the Board of Management and CEO in fulfilling assigned duties. Regular discussions were held to clarify matters before official opinions were issued. Reports to the General Meeting of Shareholders and periodic financial review reports of the Board of Supervisors were shared with the Board of Management and CEO for input before finalization.

The BOM invited the Board of Supervisors to attend its meetings. The Corporation regularly supported and facilitated the Board of Supervisors' activities.
