I. Activities of the General Meeting of Shareholders (GMS).

- On April 20, 2024, PGBank held its annual General Meeting of Shareholders for 2024 to approve several key contents such as: Approving the financial plan for 2024, approving the business plan for 2024, approving amendments to the charter for 2024, approving the regulations on the organization and operation of the Board of Directors, the Supervisory Board and certain other issues.
- On August 23, 2024, PGBank held an extraordinary General Meeting of Shareholders for 2024 to approve the followings: Election approval of 02 additional independent members of the Board of Directors and the relocation of PGBank's headquarters.
- The General Meeting of Shareholders held in-person attracted a large number of shareholders and recorded many contributions to the development plan of the Bank.

In addition to the meetings mentioned above, the Board of Directors regularly exchanges and provides guidance on the Bank's activities through written opinions.

3. The monitoring activities of the Board of Directors over the Board of General Directors

- Directing the implementation of the restructuring plan associated with debt resolution for 2021-2025. Resolving definitively existing issues, violations, and potential risks in banking operations. Intensifying the handling of bad debts, improving credit quality, and preventing and minimizing the emergence of new bad debts. Controlling and addressing bad debts, potential debts, bad debts sold to VAMC. Striving to maintain the ratio of on-balance sheet bad debts of PGBank, unresolved and unrecovered bad debts sold to VAMC, and potential bad debts at below 3% by the end of 2025 .
- Directing the successful organization of the 2024 Annual General Meeting of Shareholders and the extraordinary General Meeting of Shareholders in 2024. Accordingly, the PGBank General Meeting of Shareholders has approved several key contents such as the approval of the 2024 business plan, the dismissal of some members of the Board of Directors for the term 2020-2025, the amendment of the Charter, the approval of the charter capital increase plan, the election of additional personnel to the Board of Directors for the term 2020-2025, the approval of the change of the headquarters location of PGBank, and several other matters.
- Directing the completion of the system of processes/regulations in accordance with the provisions of the Law on Credit Institutions in 2024, officially issuing documents to update/amend internal regulations such as the Capital Contribution Regulation, Share Purchase Regulation, Internal Credit Rating Regulation, Information Disclosure Regulation,

Debt Trading Regulation, Credit Approval Regulation, Deposit Regulation, Financial Regulation, Loan Regulation, Corporate Bond Trading Regulation, and Consulting Operation Regulation. The content of amendments and supplements must comply with the provisions of the Law on Credit Institutions in 2024 and related legal documents.

- Directing the completion of the plan to increase the charter capital of PGBank according to Resolution No. 08/2023/NQ-ĐHĐCĐ dated October 23, 2023, raising the charter capital from 3 trillion to 4.2 trillion.
- Approving the implementation of the plan to issue an increase in charter capital in 2024 for existing shareholders and plan helps supplement capital for operations, in line with the development strategy for the period 2021-2025.
- Continuing to direct the implementation of completing the procedures for obtaining approval from the State Bank of Vietnam regarding the establishment of branches in Thai Nguyen, Nghe An, Thanh Hoa, Dong Anh, and Ninh Binh. At the same time, through the repair and relocation of the headquarters of PGBank's branches and transaction offices to convenient locations with large premises, creating a professional and modern brand image for customers and partners.
- Strengthening the high-level human resource management, improve the policies for employees, promote the development of capabilities, and seek to attract and develop talents. In 2024, the Board of Directors approved the appointment of a General Director and the appointment of 03 Deputy General Directors, specifically appointing Mr. Nguyen Van Huong as General Director, appointing Mr. Tran Van Luan as Permanent Deputy General Director; appointing Mr. Le Van Phu as Deputy General Director in charge of risk management, re-evaluation and credit approval, debt handling and recovery; appointing Mr. Nguyen Trong Chien in charge of Operations, valuation, and financial work.
- Organizing regular monthly/extraordinary Board of Directors meetings to hear reports from the General Director on operational status while maintaining the monitoring regime according to delegated authority.
- Directing the inspection, review, and periodic/unexpected evaluation of the business units' activities, understand the difficulties and obstacles, and provide timely directives for the operations of each branch.
- Instructing the Executive Board to implement the three breakthrough solutions of the Government: perfecting the institution (reviewing processes and regulations; shortening processing time, increasing efficiency); developing human resources (establishing incentive mechanisms, training human resources); developing infrastructure (focusing on implementing IT projects, synchronizing facilities across the system).

In general, in 2024, the Board of Directors supervised and directed the Board of Management in the Bank's operations in accordance with the strategic orientation and goals. The Board of Directors oriented and directed the Board of Management on business planning, institutional development, and competitiveness enhancement (through building an effective lean model, minimizing processes, investing in technology, and developing highly qualified human resources). The Board of Management actively implemented the Board of Directors' directions to complete the Bank's business plan and achieve significant growth.

4. The activities of the Committees under the Board of Directors.

The Board of Directors of PGBank has a Human Resources Committee, a Risk Management Committee, other councils/committees under the Board of Directors, and the Office of the Board of Directors that perform advisory functions and assist the Board of Directors in accordance with the law and the regulations issued by PGBank at each period, in which:

- The Human Resources Committee advises the Board of Directors on handling personnel issues arising during the process of conducting elections, appointments, dismissals, and removals of members of the Board of Directors, the Supervisory Board, Executives, and managerial officers of PGBank under the authority of the Board of Directors as prescribed. It advises the Board of Directors in issuing internal regulations of PGBank under the authority of the Board of Directors regarding salary policies, remuneration, bonuses, personnel regulations, training, and other personnel-related matters.
- The Risk Management Committee advises the Board of Directors in issuing processes and policies under its authority related to risk management in banking operations. It analyzes and provides warnings about the safety level of the bank against potential risks that may affect it and preventive measures for these risks in both the short term and long term.
- The Risk Management Council approves or decides on the classification of debts, off-balance sheet commitments, the establishment of provisions, and the use of provisions to manage credit risks throughout the system; approves the consolidated report of the entire system and the results of debt recovery that have used provisions to manage risks, including the results of handling secured assets and clearly determining the basis for the approval; decides or approves measures for debt recovery that have used provisions to manage risks throughout the system, including the handling of secured assets.
- The Office of the Board of Directors: Advises and assists the Board of Directors in performing its leadership and management functions over the Bank's operations in accordance with the law and the PGBank Charter.

2. Meeting of the Supervisory Board

In 2024, the Supervisory Board of Prosperity And Development Commercial Joint Stock Bank held 34 meetings to discuss and reach consensus on issues within the authority, functions, and tasks of the Supervisory Board. The meetings were conducted validly with attendance at a sufficient ratio to proceed with the meetings of the Supervisory Board members. The members of the Supervisory Board discussed and unanimously approved issues within the authority and tasks of the Supervisory Board with voting ratios in accordance with the provisions of the law, the Charter, and the Regulations on the organization and operation of the Supervisory Board. The content of the meetings was recorded in meeting minutes, which are stored at the Supervisory Board according to the Regulations on the organization and operation of the Supervisory Board, serving as a basis for the Supervisory Board to implement tasks within its authority and responsibilities.

3. The supervisory activities of the Supervisory Board over the Board of Directors and the General Director.

3.1 The supervisory activities of the Supervisory Board with the Board of Directors.

- The Supervisory Board has monitored the Board of Directors in the implementation of the resolutions of the General Meeting of Shareholders (GMS) in 2024 according to the roadmap.
- The Supervisory Board has monitored the results of the high-level management supervision of the Board of Directors with the General Director regarding the implementation of the resolutions of the GMS and the Board of Directors; monitored the construction and implementation of the internal control system, the development and implementation of risk management policies through supervisory and internal audit activities; monitored the approval and implementation of investment projects for the purchase and sale of fixed assets, contracts, and other transactions of the Bank in accordance with the provisions of the Law on Credit Institutions 2024.

- Supervising the Board of Directors in organizing the revision of recommendations from the State Bank of Vietnam's Inspectorate, independent auditors, internal auditors, and other external state inspection agencies related to the activities and responsibilities of the Board of Directors.
- The Supervisory Board participates in the Board of Directors' direct meetings, receives all documents and records presented to the Board during direct meetings or obtains the Board's opinions in writing to understand and provide feedback on compliance with legal regulations regarding the contents submitted for the Board's approval authority.
- The results of internal audit activities and the recommendations of the Supervisory Board are sent to the Board of Directors so that the Board can grasp the issues identified and provide direction for implementation on matters within the Board's authority. The supporting unit of the Supervisory Board is the Internal Audit Department, which monitors the implementation of recommendations of the Supervisory Board and the Internal Audit Department to the Board of Directors.

3.2 The Supervisory Board's oversight activities regarding the General Director

- Monitoring the results of the high-level management supervision of the General Director (DG) and the units directly under the DG through internal audit activities.
- Supervising the DG in addressing the recommendations of the State Bank of Vietnam's Inspectorate, independent auditors, internal auditors, and other external state inspection agencies related to the activities and responsibilities of the DG.
- Through monitoring activities and internal audits to oversee the organization of business operations, management, administration, and risk management concerning the units/individuals managed by the DG; validating the financial reports for the first six months and annually of the bank.
- Participating and providing opinions (if necessary) at the Executive Board meetings or other meetings of the Executive Board.
- The results of the internal audit activities and the recommendations of the Supervisory Board (SB) are sent to the General Director (DG) for DG to grasp the issues identified and to direct the implementation of matters within DG 's authority. The department assisting the SB is the Internal Audit Department (IAD), which monitors the implementation of the SB's recommendations to DG.

4. The coordination of activities between the Supervisory Board (SB) and the Board of Directors (BoD), General Director (DG), and other management positions.

- The coordination mechanism between the SB and the BoD, DG ensures full compliance with legal regulations and internal regulations of PGBank, for the common goal of sustainable development of PGBank.
