Based on the financial report of Q2.2025. Profit after tax in Q2.2025 decreased by more than 10% compared to Q2.2024. Specifically as follows:

Profit after tax in Q2/2025 decreased by VND 1,731,681,168, down 88.03% compared to the same period last year. The reasons for the decrease in profit in Q2/2025 are:

- 1st: Revenue in Q2/2025 decreased by 47.71% compared to the same period last year.
- Second: Gross profit margin decreased from 9.93% to 4.76% in the second quarter of 2025, equivalent to a decrease of 52.05% compared to the same period last year.

Above is the explanation for the reason for the decrease in profit compared to the same period last year of Plastic Additives Joint Stock Company.
