Regarding the difference in after-tax profit on the Income Statement for Q1 2025 compared to Q1 2024:

** On the Company's Separate Financial Statements:*

- Post-tax profit for Q1 2025: -137,802,254 VND
- Post-tax profit for Q1 2024: -120,352,198 VND

** On the Company's Consolidated Financial Statements:*

- Post-tax profit for Q1 2025: -140,800,936 VND
- Post-tax profit for Q1 2024: -123,403,933 VND

Post-tax profit on both the Separate and Consolidated Financial Statements for Q1 2025 decreased by 14% compared to Q1 2024

Reason: The company's management expenses in Q1 2025 increased compared to Q1 2024, leading to lower profit in Q1 2025 compared to Q1 2024.

Regarding the post-tax loss in Q1 2025 on the Separate and Consolidated Financial Statements:



- Post-tax profit on the Separate Financial Statements for Q1 2025: -137,802,254 VND
- Post-tax profit on the Consolidated Financial Statements for Q1 2025: -140,800,936 VND

Reason: In Q1 2025, the company's revenue was too low to cover management expenses, resulting in a post-tax loss on both the Separate and Consolidated Financial Statements.
