Preface

In order to implement Statistical Law and the Governmental Degree numbered 40/2004/ND-CP on provision and detailed guidance of some articles of the Statistical Law, on 23 January, 2007, the Prime Minister had Decision numbered 10/2007/ND-CP issued the Viet Nam Standard Industrial Classification 2007. This Decision replaced previous provisions of Viet Nam Standard Industrial Classification.

Viet Nam Standard Industrial Classification 2007 (VSIC 2007) was built by the General Statistics Office (GSO) on the basis of International Standard Industrial Classification revision 4 (ISIC Rev.4) passed by United Nation Statistical Division on the meeting in March, 2006 and the Draft ASEAN Common Industrial Classification (ACIC) detailed to 3 digits. Also base on the current status of the use of Viet Nam Standard Industrial Classification issued 1993 and the statistical survey demand, General Statistics Office has developed VSIC detailed to 5 digits.

The provision on the contents of each economic industry of VSIC 2007 was issued by the Minister of Ministry of Planning and Investment at the decision numbered 337/2007/QD-BKH on 10 April, 2007.

In the building process of VSIC, GSO received comments from line ministries and branches and the supports from UNDP Ha Noi. On this occasion, GSO kindly express sincere thanks to the above ministries, branches and UNDP Ha Noi.

To make convenience for organizations and bodies in the using process, GSO has published the book: "Viet Nam Standard Industrial Classification 2007".
