2. The supervision on CEO by the Board of Management

Under the Constitution of the Company and the Corporate Governance Policy of the Company, the Board of Management (BOM) conducted its check and supervision on the CEO's implementation of the AGM's and the BOM's resolutions in 2014 as follows:

2.1 The methods of supervision

 Through the BOM meetings organized quarterly and on demand, the BOM had discussion and inquiries on the CEO's implementation of the strategy, business plan and targets approved by the AGM. The CEO actively made adequate, detailed and timely provision of information and reports on their progressions, pointing out difficulties and obstacles; analyzing causes and proposing solutions. The discussions and opinion exchanges were carried out on the spirit of straightforwardness, contributiveness and on the interests of the Company and shareholders in order to outline and promptly organize the implementation of solutions to achieve the targets assigned by the AGM.

- The BOM, directly or through the Sub-committee of Risk Management (SRM) in cooperation with the Inspection Committee (IC), conveyed their constructive opinions and comments to the CEO and the Board of Directors (BOD) in a bid to pecfect the Company's policies, internal processes and procedures, business performance, and to enhance corporate governance capability. The IC's comments were all appreciated and taken into consideration before the decisions of the BOM and CEO were made.
- In addition, through the SRM, the BOM worked with the Department of Risk Management and Internal Control (DRMIC) to develop a risk management structure fit with international standards and norms.
- The BOM discussed and approved resolutions after each meeting, including the following quarters' business plans and other issues that the CEO upheld to fulfill her duties and responsibilities.
 - 2.2. Results of the supervision
- Year 2014 continued a year of difficulties for FMCG companies. The market demand was still weak.
 The overall growth of the economy remained low.
- Under the management of the CEO and the BOD, the Company, basically, achieved its business targets, maintaining and increasing its market shares in key products, expanding its distribution network, continuing its diversification of products, etc.

- Investment activities:
 - The performance of its subsidiaries and associates continued improved, earning more returns for shareholders.
 - The projects of expanding farms, upgrading current production facilities and overseas investments continued to be developed, prepared conditions precedent for the sustainable growth of the Company in the coming time.
- The Company continued its leading position, reputation and image in the market along with plenty of international and local awards and accolades for the CEO and the collective.

2.3. Conclusion

In the review of the BOM, despite of unfavorable business environment, the CEO and the BOD did their excellent job completing their missions for 2014, upholding the applicable laws and regulations, and the policies of the Company.

3. The activities of the sub-committees under the Board of Management

In 2014, Vinamilk's BOM continued its governance in the trend of quality improvement:

- The BOM organized its activities in accordance with the Constitution and the Governance Policy of the Company in terms of number of meetings, member attendances to meet statutory requirements and maintain the meetings effective.
- The sub-committees organized their activities in accordance with the mechanism of operation, fulfilled their own duties stipulated for each sub-committee. The activities and implementation results of the sub-committees were all reported blatantly and timely to the BOM. Each of the members actively and responsively conducted their duties and contributed their own opinions and comments to collective decisions.
- Provided express and workable guidance and close supervision on the implementation of the AGM resolutions and the business of the Company.
- The BOM also provided its guidance and supervision on the implementation of important plans of the Company, such as Risk Management System, Succession Plan.
- The supervision on the CEO's activities and Senior Management Officers was conducted effectively.
- In 2014, the BOM made its consideration and appointment of Executive Directors of Marketing, of Administration Human Resources Public Relation, and of Raw material Development.
- The SRM worked closely with the DRMIC and the consultant (KPMG) on the activities of risk management as well as preparations for the following quarters: conducting the instruction of developing CSA (Control Self-Assessment) for 2 risks Risk of product contamination and risk of Business Strategy Performance and preparing the development of CSA for the remaining Top risks, developing risk scales and parameters, requesting risk owners to review, propose and specify descriptions and scales of target risks for corresponding Top risks so that the SRM and the BOM could review and focus on risks in the strategic category (competition, key staff, plan/strategy implementation). The evaluation had to go along with the review of policies, etc.
