RESOLUTION BOARD OF DIRECTORS - DIGIWORLD CORPORATION

(About: Loans at Vietnam Technological and Commercial Joint Stock Bank – TECHCOMBANK)

- Pursuant to Charter of Digiworld Corporation dated April 06th, 2022("the Company");
- Pursuant to Meeting Minutes of Board of Directors No. 39/2022/BB-HĐQT dated September 29th, 2022.

RESOLVED THAT

I. RATIFICATION OF THE FOLLOWING MATTERS:

- 1. Approving the plan to apply for credit to Digiworld Corporation at Vietnam Technological and Commercial Joint Stock Bank (TECHCOMBANK).
- 2. The Board of Directors agreed on the use of the total short-term credit limit at Vietnam Technological and Commercial Joint Stock Bank (TECHCOMBANK) as follows:
- Total credit limit: 800,000,000,000 VND (In words: Eight hundred billion VND), of which:
 - Loan limit: VND 800,000,000,000 Guarantee limit balance L/C limit balance (In words: Eight hundred billion vnd guarantee limit balance L/C limit balance)
 - Guarantee limit: VND 800,000,000,000 Loan limit balance L/C limit balance (In words: Eight hundred billion VND Loan limit balance L/C limit balance)
 - L/C limit: VND 800,000,000,000 Loan limit balance Guarantee limit balance (In words: Eight hundred billion VND Loan limit balance guarantee limit balance)
- Purpose of the loan: Supplementing working capital, issuing guarantees, opening LC to buy and sell goods/materials for the company's production of technology products, fast-moving consumer goods and health care.
- Source of debt repayment: From business activities and other revenue sources of Digiworld Corporation.
- KUNN term: up to 3 months according to each debt contract.
- Interest rate: According to TECHCOMBANK's regulations in each period.
- Loan method: According to the credit limit.
- Loan security measures: Grant unsecured credit.
- 3. The Board of Directors unanimously appointed Mr. DOAN HONG VIET Position: Chairman of the Board of Directors, currently the legal representative of Digiworld Corporation, or Ms. DANG KIEN PHUONG Position: General Director, currently the legal representative of Digiworld Corporation or Ms. TO HONG TRANG Position: The Deputy General Director signs and executes credit contracts, debt contracts, mortgage/pledge contracts, guarantee contracts and all other related transaction papers with Vietnam Technological and Commercial Joint Stock Bank ("Authorized Person").
- 4. Mr. DOAN HONG VIET Position: Chairman of the Board of Directors, currently the legal representative of Digiworld Corporation and Ms. DANG KIEN PHUONG Position: General Director, currently the legal representative of Digiworld Corporation fully agreed on the authorization for Ms. TO HONG TRANG Position: The Deputy General Director signs and performs the above tasks.

- 5. To the extent authorized under this Resolution, the Authorized Person of the Resolution is permitted to reauthorize third parties as necessary.
- 6. Members of Digiworld Corporation commit to use all revenues and assets of the company to prioritize debt repayment of Vietnam Technological and Commercial Joint Stock Bank according to the repayment schedule prescribed by the bank before other individuals and credit institutions. For any reason, the company fails to repay the bank debt, the company undertakes to voluntarily hand over all collateral and pledged assets for the bank to handle to recover the debt without causing any hindrance. Vietnam Technological and Commercial Joint Stock Bank is entitled to deduct money from the company's account to collect debts when they are due.
- 7. The Board of Directors unanimously approved the content of the credit contract expected to be signed with TECHCOMBANK with specific terms and conditions stated in it. The Board of Directors undertakes that Digiworld Corporation will strictly comply with those terms and conditions.

II. CERTIFICATION AND COMMUNICATION OF THE RESOLUTION

This Resolution becomes effective from the date of signing at the first page expressed as signature of the competent person(s). One (01) original copy of this Resolution is furnished to the Bank, and it shall remain in force and the Bank may rely upon this Resolution and the authorities granted hereunder until the Bank has received and acknowledged an original of another resolution revoking or modifying this Resolution.
