Song Ba Joint Stock Company (Stock Code: SBA) hereby reports the profit of quarter 3/2022 and quarter 3/2021 as follows:

- Profit after CIT of quarter 3/2022: 53,859,845,398 VND.

- Profit after CIT of quarter 3/2021: 15,272,509,080 VND.

Profit after CIT of quarter 3/2022 was increased compared to the quarter 3/2021 with an amount of **38,587,336,318 VND**.

The main reason leading to an increase in business result of quarter 3/2022 compared to quarter 3/2021 was as follows:

In quarter 3/2022, the weather was favorable, Capacity of water flowing to the Hydropower reservoirs of SBA was more than that of the quarter 3/2021, so quantity electricity generation and revenue increased respectively by 101.28% and 57,33 billion VND over the same period in 2021. Although the cost of goods sold increased by 15.18 billion VND (Mainly due to the increase in depreciation expense based by quantity electricity generation), but profit after CIT of quarter 3/2022 has been increased **38.59** billion VND, compared to quarter 3/2021, which was equivalent to an increase rate of **252.66%**.
