The company was granted the Securities Registration Certificate No. 25/2009/GCNCP-VSD-15 by the Vietnam Securities Depository Center - Ho Chi Minh City Branch on January 17, 2023, and the Decision No. 34/QD-SGDHCM issued by the Ho Chi Minh City Stock Exchange on January 18, 2023 on the change of listing registration. The total number of current securities is 80,493,048 shares.

On July 18, 2023, the Company received Official Letter No. 4706/UBCK-PTTT from the State Securities Commission on the dossier of notification of change of the Company's maximum foreign ownership, according to which, the maximum foreign ownership ratio in Dong Hai Joint Stock Company of Ben Tre is 50%.
