Sales and service revenue in the fourth quarter of 2024 reached 14.097.920.322 VND, an increase of 2.792.626.584 VND. The cost of goods sold decreased by 100.839.644 VND compared to the fourth quarter of 2023, resulting in a gross profit from sales and service provision in the fourth quarter of 2024 that increased by 2.893.466.228 VND compared to the same period in 2023. Financial revenue in the fourth quarter of 2024 decreased by 858.255.369 VND compared to the fourth quarter of 2023 due to a decrease in term deposits, as the Company paid dividends to

CÔNG CỔ PH KHÁCH SÀI G shareholders in 2024 according to Resolution No. 01/NQ-DHDCD2024 dated June 26, 2024, by the 2024 Annual General Meeting of Shareholders regarding the profit distribution for 2023. Administrative expenses in the fourth quarter of 2024 increased by 27.954.475 VND compared to the fourth quarter of 2023. The strong revenue growth significantly reduced the raw material consumption rate, driving a remarkable increase of VND 1.899.220.564 in pre-tax profit for the fourth quarter of 2024 compared to the same period in 2023. This resulted in an increase of 1.514.697.740 VND in after-tax profit in the fourth quarter of 2024 compared to the same period in 2023.
