Thong Nhat Rubber Company hereby explains the fluctuations in business performance for the third quarter of 2024, with net profit after corporate income tax changing by 10% or more compared to the same period in the previous year as follows:

2	Net profit after corporate income tax	13.024.558.956	5.106.669.029	7.917.889.927	155%

The net profit after corporate income tax for Q4 2024 reached **13,024,558,956 VND**, an increase of **7,917,889,927 VND** compared to Q4 2023, corresponding to a growth rate of 155%. This increase is attributed to the higher banana selling prices in Q4 2024 compared to Q4 2023, which led to a rise in profits from banana production and business activities by a corresponding amount of **11,887,702,700 VND**. Additionally, profits from the liquidation of rubber trees increased compared to Q4 2023 by a corresponding amount of **7,363,759,531 VND**.
