The Company would like to explains the variations in profit after corporate income tax in the fourth quarter of 2024 on its own independent financial statements as follows:

Target	Fourth quarter of 2023	Fourth quarter of 2024	Variation
Profit after corporate income tax	391,433,874	1,827,938,054	367%

The business made 1,827,938,054 VND in the fourth quarter of 2024, a 367% increase in profit over the same period in 2023.

Reason:

The hotel business has been moved to a subsidiary so that the company can concentrate on completing projects in Laos. As a result, the company does not make money from production or commercial operations.

Financial revenue from the revaluation of foreign currency principals increased by 1,967,705,602 VND compared to the fourth quarter of 2023 (due to fluctuations), which is equivalent to 502.69% of the profit in fourth quarter of 2023. This indicates the significant impact of fluctuations in the foreign exchange rates between USD/VND in the fourth quarter of 2024 and 2023.

However, operational expenses, salaries, depreciation of fixed assets, other securities, etc., accounted for 291,659,579 VND, which was higher than the profit for the fourth quarter of 2023, which was 44,430,859 VND (a change of 11.35%).

Due to the aforementioned variables, Urban Development and Design Consulting Joint Stock Company's profit after taxes increased by 367 percent in the fourth quarter of 2024 as compared to the fourth quarter of 2023.

The Urban Development and Design Consulting Joint Stock Company's explanation of production and business activity changes in its separate financial statements is provided above.
