3.1. Results of monitoring the Board of Directors' activities

- In 2024, the Board of Directors successfully held the 2024 Annual General Meeting of Shareholders on April 9, 2024.
- The Board of Directors held 04 Board meetings with the participation of the Board of Supervisors. In 2024, the Board of Directors issued 74 resolutions and decisions. The resolutions and decisions were unanimously approved by all participating members and reflected the Company's orientation, strategy and business solutions in line with the general policy of the State and the market context. The Board of Directors operated in accordance with the functions, tasks and powers stipulated in the Charter, internal regulations on corporate governance, operating regulations of the Board of Directors and current legal regulations; always proactively and enthusiastically implemented and completed the tasks approved by the General Meeting of Shareholders, ensuring the best interests of the Company and shareholders.
- The Board of Directors has organized many sessions to collect opinions in writing, direct Board of Directors meetings as well as exchanges via email, members have contributed constructive opinions or responsibly criticized issues under the authority and responsibility of the Board of Directors. The meetings focused on the main contents: Production and business plan, Company development strategy, organizational model, policy mechanism, project investment. Resolutions and decisions of the Board of Directors were issued within their authority, in accordance with the Company Charter and legal regulations.
- The implementation of information disclosure is directed by the Board of Directors to comply with State regulations.

3.2. Results of monitoring the General Director's activities

- In 2024, the General Director and the Board of Directors proactively carried out the tasks and targets approved by the General Meeting of Shareholders and the Board of Directors; during the operation process, they always demonstrated a high sense of responsibility, overcame development difficulties, maintained existing markets, expanded domestic and foreign markets, strengthened marketing activities, and promoted the image of Da Nang Port.
