In the fourth quarter of 2024, although the total revenue from the Company's business activities increased (up 11.3 billion VND compared to the same period last year), the decline in real estate revenue has reduced the Company's business profit compared to the same period last year.

Real estate business revenue in Q4 2024 reached 1.923 trillion VND, while in Q3 2023 it was 2.656 trillion VND, a decrease of 733 million VND.
