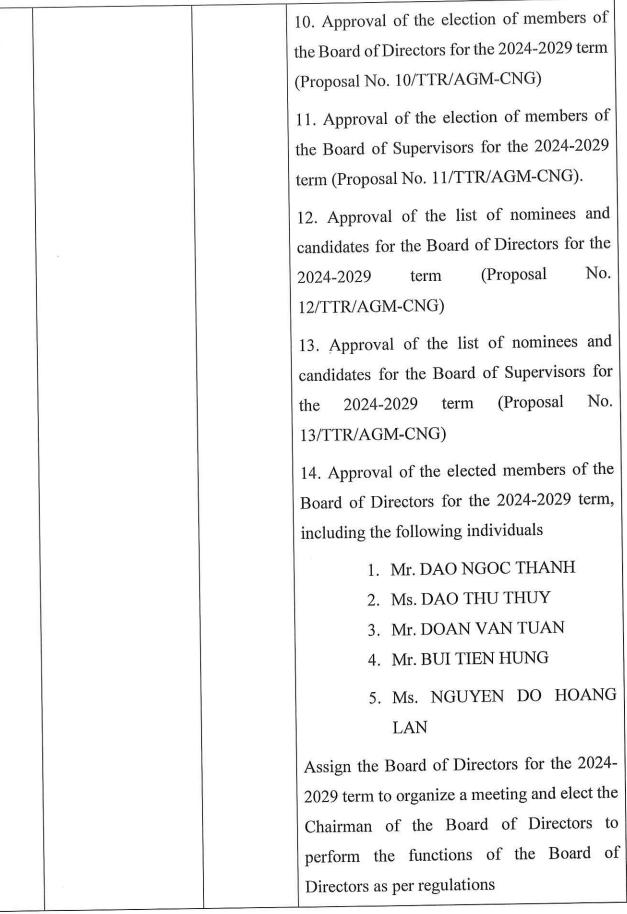

The Board of Directors has supervised the activities of the Board of Management in carrying out the following tasks

- Directed the preparation of the parent company's financial statements, consolidated financial statements for the fourth quarter of 2023, and the audited financial statements for 2023 (parent company and consolidated); preparation of the parent company's financial statements, consolidated financial statements for the first quarter, the second quarter, and the third quarter of 2024 in accordance with legal regulations; 2023 Annual Report; 2024 Semi-Annual Governance Report.;
- Executed the dividend payment for 2023 (at a rate of 20% in shares) to increase the charter capital from VND 311,747,190,000 to VND 374,089,820,000;
- 4. Activities of the Board of Directors' subcommittees (If any):
- ✓ Finance Sub-Committee: The Finance Board is responsible for preserving and developing capital, managing corporate finances effectively, meeting the financial needs of the Company's projects and works, as well as the capital contribution of the Company in its subsidiaries and affiliated companies.

The Company's goal in the coming years is to develop the project, creating a key ecological tourism and resort area in Central Vietnam. In addition, the Board of Directors is also directing the acceleration of investment research for the Phu Ho and Phu Vang New Urban Area projects in Thua Thien Hue Province, which are also key and highly potential projects of Cotana Group Joint Stock Company

- ✓ Environmental Safety and Hygiene Sub-Committee: The management of labor safety and environmental hygiene has always been a priority for the Board of Directors. The Company's labor safety committee regularly provides training on labor safety for workers, issues full protective gear, organizes regular health checkups, and provides medicine to employees to ensure their peace of mind while working.
- ✓ Sub-Committee for Managing Subsidiaries and Affiliated Companies: The Chairman of the Member Council organizes regular meetings to keep track of and provide timely direction for the overall business development of Cotana Group. In addition, the Member Council of Cotana Group organizes collective activities and mobilizes subsidiaries and affiliated companies to participate, aiming to create a cohesive, proactive, and creative environment—working together to implement the resolutions of the Member Council of Cotana Group.
- ✓ Sub-Committee for Party and Union Affairs: With the goal of strengthening solidarity within Cotana Group, the Trade Union and Youth Union have successfully organized activities such as: International Women's Day discussions on March 8th, charitable trips, flood relief donations, and visits to fallen heroes and martyrs.
- ✓ Sub-Committee for Construction Management: To meet the requirements for progress and efficiency in construction work, the Board of Directors has directed the General Director Board to review and recruit qualified personnel for this subcommittee.
