Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020 of the Ministry of Finance on guidance on information disclosure on the stock market, Dong Nai Water Joint Stock Company explains the situation of fluctuations in Profit after CIT in the fourth quarter of 2024, which increased by more than 10% compared to Profit after CIT in the fourth quarter of 2023 as follows:

1. Revenue and other income in the fourth quarter of 2024 reached VND 291,955,891,911, an increase of VND 16,386,371,539 compared to revenue and other income in the same period of 2023 (reaching VND 275,569,520,372), equivalent to an increase of 5.95%.

2. The Company's total expenses in the fourth quarter of 2024 reached VND 215,438,236,657, compared to the same period in 2023, it was VND 214,023,039,617, an increase of VND 1,415,197,040, equivalent to an increase of 0.66%.

3. CIT rate for water production activities in 2023: 5%; 2024: 10% The combination of the above impacts caused the profit after CIT in the fourth quarter of 2024 to increase by VND 10,096,774,455 compared to the same period in 2023, equivalent to an increase of 17.27%.

Reasons for fluctuations in profit after CIT of consolidated financial statements:

1. Total revenue and other income in the fourth quarter of 2024 of the parent company and its subsidiaries reached 336,106,219,811 VND, increased by 21,287,639,197 VND compared to revenue and other income in the same period of 2023 (reaching VND 315,776,918,416 VND), corresponding to an increase of 6.76%.
