NET Detergent Joint-Stock Company (hereinafter referred to as "the Company") hereby provides an explanation regarding the variation in profit after tax of the Company for the 3rd Quarter of 2025 compared to the same period in 2024 as follows:

The profit after tax decreased by 17% compared to the corresponding period last year primarily driven by the following factors:

- Net operating profit before tax decreased by 14%, as the results of net revenue decreased by 3% compared to the same period last year, primarily due to the decline in detergent powder and dishwashing liquid sales. This was partially offset by the growth of liquid detergent during the period.
- Net financial income increased by 74%, compared to the same period last year, primarily driven by optimized cash flow for investment activities.
