Dak Lak Water Supply Joint Stock Company would like to explain that the profit after corporate income tax in the Financial Report for the third quarter of 2025 ending on September 30, 2025 has changed by 10% or more compared to the Financial Report for the same period of the previous year, the third quarter of 2024, specifically as follows:

Profit after corporate income tax in the financial report of the third quarter of 2025 is 24,156,269,567 VND compared to the profit after tax in the same period last year, which is 17,349,306,609 VND, the difference in profit after tax this period compared to the previous period is 6,806,962,958 VND (equivalent to an increase of 39.23%). The reason is that the revenue in the third quarter of 2025 increased compared to the revenue in the third quarter of 2024, which is 13,482,419,103 VND (equivalent to an increase of 18.49%), on the other hand, the output of commercial water supplied to consumers increased due to higher demand from

customers compared to the same period last year. Meanwhile, total expenses in this period increased by VND 5,820,843,004 compared to the same period last year (equivalent to an increase of 10,90%), the increase in expenses was lower than the increase in revenue, leading to pre-tax profit in the third quarter of 2025 increasing by VND 7,661,576,099 (equivalent to an increase of 39.29%) compared to the same period last year. After calculating corporate income tax payable, after-tax profit reached 24,156,269,567 VND, an increase of VND 6,806,962,958 (equivalent to an increase of 39,23%), leading to after-tax profit changing by 10% or more compared to the report in the same period last year.
