Song Da Industry Trade Joint Stock Company would like to explain the difference in net revenue and profit after tax in the financial statements for the third quarter of 2025 compared to the same period last year, specifically as follows:

Reasons:

Total revenue from sales of goods and consumption of products in the third quarter of 2025 decreased by 10.5 billion VND compared to the same period in 2024, mainly due to:

- Volume of goods consumed in the third quarter of 2025: The volume of plastic consumed decreased by 47 tons compared to the same period in 2024, decreasing the revenue from sale of goods by 0.84 billion VND compared to the same period in 2024;
- The volume of finished packaging products consumed decreased by 1.72 million, decreasing the revenue from sale of semi-finished products by 9.66 billion VND compared to the same period in 2024.

The total profit after tax in the third quarter of 2025 increased by 0.79 billion VND compared to the same period in 2024, mainly due to: The price of main input materials which were plastic grains and paper decreased, increasing the profit in the third quarter of 2025 compared to the same period last year.

Above is the explanation of the main reasons for the decrease in sales revenue, increase in Profit after tax in the third quarter of 2025 compared to the same period in 2024 of Song Da Industry Trade Joint Stock Company.
