financial statements and in the consolidated financial statements for the quarter III, 2025 of
the Company as follows:

I. In the separate financial statements for the quarter III, 2025

The Profit After Corporate Income Tax in Quarter III of 2025 increased compared to Quarter III of 2024, with details as follows:

Profit after corporate income tax	5.29	1.85	3.44	185%

The Company's profit from operating activities in Quarter III of 2025 increased significantly (by 185%) compared to the same period last year, rising from VND 1.85 billion in Quarter III of 2024 to VND 5.29 billion in Quarter III of 2025. The main reason for this surge was a

VND 4.5 billion compared to the same period of the previous year.

II. In the consolidated financial statements for the quarter III, 2025

The Profit After Consolidated Income Tax in Quarter III of 2025 increased compared to Quarter III of 2024, with details as follows:

Profit after corporate income tax	8.32	3.02	5.3	175%

Net profit from operating activities in Quarter III of 2025 (VND 8.32 billion) increased by VND 5.3 billion compared to the same period in 2024 (VND 3.02 billion). The reason for this growth is as follows:

- The parent company's profit increased by 185%, equivalent to a rise of VND 3.44 billion.
- The subsidiary's profit increased by 76%, equivalent to a rise of VND 1.8 billion.

The above is the explanation from Picomat Plastic Joint Stock Company regarding the fluctuations in profit after corporate income tax in the separate financial statements and in the consolidated financial statements for the quarter III 2025 compared to quarter III 2024.
