Century Synthetic Fiber Corporation explains the fluctuations in profit indicators before and after the audit for 2024 for the Consolidated and Parent Company Financial Statements, which were audited on March 7, 2025, as follows:

#### Reasons:

Net revenue before and after the audit remains unchanged; however, the differences in profit before and after tax are as follows:

## Parent Company Financial Statements:

Profit before tax increased by VND 4.8 billion, equivalent to an 8.9% rise, and net profit after tax increased by VND 4.7 billion, equivalent to a 10.1% rise. This is due to the audit recognizing additional financial income from the Parent Company's internal lending to its subsidiary, Unitex.

#### • Consolidated Financial Statements:

Profit before tax decreased by VND 33.5 billion, equivalent to a 63.9% decline, and net profit after tax decreased by VND 33.2 billion, equivalent to a 72.8% decline. This was due to a change

in the accounting treatment of unrealized foreign exchange differences related to the Unitex Project – a subsidiary that has not yet commenced operations.

- o In the unaudited financial statements, this amount was recorded as an asset to be allocated over five years, following the guidance in Clause 2.21, Article 4 of Circular 96/2015/TT-BTC. It was anticipated that once the project became operational, this foreign exchange difference would be allocated to financial expenses over a period not exceeding five years.
- o However, in the audited financial statements, based on the auditing firm's advisory opinion, this foreign exchange difference was directly recorded as a financial expense in accordance with Circular 200/2014/TT-BTC.
