- Revenue in 2024 reached 306,85 billion VND and profit after tax reached 42,36 billion VND, down 6,17% and 26,57% respectively compared to 2023.
- Revenue and profit after tax in 2024 compared to the business plan are 83,75% and 70,61% respectively.

### Reason:

Revenue decreased, cost of goods sold increased, leading to a 12,11% decrease in gross profit. The difficult economic situation resulted in slow recovery of financial investments. Financial expenses increased by 5,47% over the same period. Selling expenses decreased by 53,15% and management expenses decreased slightly by 8,52%. Other profits decreased due to late tax payment penalties. The above reasons led to a 26,57% decrease in after-tax profit in 2024 compared to the same period.
