Re: Explanation of profit after tax difference in the audited Financial Statements in 2024

To: - State Securities Commission;

Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020 of the Ministry of Finance guiding the disclosure of information on the stock market.

Based on the Company's audited Financial Statements in 2024 with the target of Profit after tax fluctuating by over 10% compared to the same period in 2023, Petrolimex Hai Phong Transportation and Service Joint Stock Company (Security code: PTS) would like to explain as follows:

1. Parent Company Financial Statements:

2. Consolidated Financial Statements:

Profit after tax in the audited Financial Statements in 2024 of the Parent Company reached VND 3,461,093,240 (an increase of VND 3,461,093,240, equivalent to an increase of 188.7% over the same period in 2023), mainly due to:

+ In 2024, the transportation market had many fluctuations, the structure and transportation routes changed, so the transportation revenue reached VND 229,725,030,190, 2.31% decrease over the same period in 2023. However, owing to cost reduction, the profit of this field reached VND 14,120,238,077, 9.65% increase over the same period. Petrolium revenue reached VND 142,664,700,930, the average sales discount increased, so the petrolium field in 2024 had a loss of VND 1,514,715,803 (a decrease in loss compared to the same period in 2023). In addition, the Company had other income, mainly from the liquidation of the PTS08 ship that has expired.

## 3. Consolidated Financial Statements:

Revenue from the field of repairing and newly building watercraft (all activities of the Subsidiary) reached VND 8,509,925,912, an increase of VND 6,180,162,271, equivalent to 265.3% increase over the same period last year. The loss was VND 245,225,348 (a decrease in loss compared to the same period in 2023) because in 2024, the market for repairing and newly building watercraft has seen many improvements.

After consolidating, the Company's profit after tax in 2024 reached VND 3,821,309,111, an increase of VND 3,442,644,177 compared to the same period in 2023, equivalent to an increase of 909.2%.
