6.2. Explanation of Post-Tax Profit Discrepancies Compared to the Previous Year

In 2024, the company's post-tax profit was VND 4,945,461,320, representing a 40% decrease compared to 2023. The primary reasons for this decline are:

- Impact of Typhoon Yagi, causing a financial loss of VND 1,038,295,642, detailed as follows:
