I. Some main contents of the Contract:

- 1. Contract Type: Lump sum.
- 2. Contract Parties: CNGVN signs a contract with PV GAS Joint Stock Corporation.
- 3. Contract Subject: Supply of equipment, construction and installation of Hyosung Quang Nam LNG station.
- 4. Contract implementation time: 60 days from the effective date of the contract, in which the completion time for installation and testing is not more than 35 days from the effective date of the contract.
- 5. Payment term: Within 20 (ten) working days from the date of receipt of the payment dossier.
- 6. Contract value:
- The total contract value is 5,006,391,610 VND (In words: Five billion six million three hundred ninety-one thousand six hundred ten dong) according to the decision approving the contractor selection results for the "LNG Equipment Supply and Installation at Hyosung Quang Nam LNG Station" package.

I. Some main contents of the Contract:

- 1. Contract Parties: CNG Vietnam Joint Stock Company (Party A) signs a fuel supply contract with Vung Tau Petroleum Joint Stock Company (Party B).
- 2. Subject of the Contract: Petroleum goods.
- 3. Contract Term: 12 months from the effective date of the Contract.
- 4. Contract Type: Adjusted unit price contract.
- 5. Payment Term: Within 30 (thirty) days after Party A receives the full original set of valid payment documents from Party B.
- 6. Contract Value:
- Total provisional contract value: 16,125,143,111 VND (In words: Sixteen billion, one hundred twenty-five million, one hundred forty-three thousand, one hundred and eleven dong) including VAT, taxes, and related fees to implement the Contract.
