After-tax profit presented in the Income Statement for the year 2024 varies by more than 10% compared to that of the year 2023:

In 2024, the Company achieved an after-tax profit of VND 217,9 billion, an increase of VND 75,4 billion, equivalent to an increase of 53% as compared to that of the year 2023. The reason was that the total revenue of 2024 increased by VND 286,3 billion, equivalent to an increase of 28% as compared to that of the year 2023; while the total expenses of 2024 increased by only VND 184 billion, equivalent to an increase of 21% as compared to that of the year 2023. In 2024, the Company's revenue and profit increased significantly thanks to the increased demand for construction materials from investment projects, traffic infrastructure projects in the Eastern and Southwestern regions under construction.
