Pursuant to Circular No. 96/2020/TT-BTC dated November 16<sup>th</sup>, 2020, issued by the Ministry of Finance, guiding information disclosure in the securities market, Petrolimex Nghe Tinh Transportation and Services Joint Stock Company (the Company) hereby provides the explanation for the 2024 profit fluctuations as reflected in the Audited Combined Financial statements for 2024 compared to the same period in 2023, as follows:

According to the Audited Combined Financial statements for 2024 of Petrolimex Nghe Tinh Transport and Services Joint Stock Company, the company recorded profit after tax of VND 19,606,364,046, representing a 57% increase compared to the same period in 2023 (VND 12,499,244,625). This fluctuation is attributed to the following reasons:

- The Company's retail sales volume increased compared to the same period, leading to a higher gross profit.
- The Company's financial expenses decreased due to access to loans with lower interest rates, resulting in reduced financial costs.
- Additionally, the Company's other income increased significantly, driven by asset liquidation and revenue from leasing locations for electric vehicle charging stations.
