RESOLUTION

- Pursuant to Decree No. 153/2020/ND-CP dated December 31, 2020, on private placements and transactions of corporate bonds in the domestic market and issuance of corporate bonds in the international market, and its amendments, supplements, and implementation guidelines (if any);
- Pursuant to the Charter of Ho Chi Minh City Development Joint Stock Commercial Bank ("HDBank");
- Pursuant to Resolution No. 447/2024/NQ-HĐQT dated December 30, 2024, of the Board of Directors of HDBank regarding the Approval of Plan for Issuance and Use of Proceeds of HDBank Bonds to be issued in the international market in 2025 ("Resolution 447");
- Pursuant to the Proposal of the Chief Executive Officer of HDBank regarding the Approval of the Offering Dossier and Repayment Plan for HDBank's 2025 International Bond Issuance;
- Pursuant to the Vote Counting Minutes of Votes in writing by Members of the Board of Directors of HDBank.

HEREBY RESOLVES:

- **Article 1**. To approve the Offering Dossier for HDBank's Bonds to be issued in the international market in 2025 ("**Bonds**") as listed in Appendix 01 ("**Offering Dossier**").
- **Article 2.** To Approve the Repayment Plan for the proceeds from the Bonds issuance, as detailed in Appendix 02 ("**Repayment Plan**").
- **Article 3.** To Authorize and delegate the Chief Executive Officer, based on specific circumstances to decide on:
 - 3.1 The signing, issuance, and submission of the Offering Dossier to the State Securities Commission of Vietnam ("SSC"), including but not limited to the following tasks:

- (i) Determining the timing for the issuance and submission of the Offering Dossier;
- (ii) Deciding on the documents and materials to be submitted to the SSC in relation to the Offering Dossier;
- (iii) Coordinating and providing explanations as may required by the SSC regarding the Offering Dossier;
- (iv) Amending, adjusting, and supplementing documents in the Offering Dossier as per the SSC's guidance; and
- (v) Performing any other tasks deemed necessary by the Chief Executive Officer to obtain the SSC's approval for the Bonds offering.
- 3.2 To perform other related tasks according to Resolution 447 and this Resolution.

Article 4. This Resolution takes effect from the date of signing.

Members of the Board of Directors, the Board of Management, Departments/Divisions/Units, and relevant individuals are responsible for implementing this Resolution.
