 - Purpose: To supply working capital, issue guarantees, provide loan payments for LC, and other credit products offered by Vietinbank Quang Ngai to serve the business of PSMT.
 - Guarantee period: From the date of signing the Loan Guarantee Letter until
 the guaranteed obligations are fulfilled, or until Vietinbank Quang Ngai and
 PSMT or Petrosetco agree to replace the existing guarantee with another
 form of guarantee.
