Expenses in 2024 reached over 1,624 billion VND, down 38.37% compared to the previous year.

During the year, revenues and expenses decreased mainly from Securities Custody Services Operations and recognition of gains and losses from financial asset investing activities. Pre-tax profit in 2024 increased by 69.85% compared to the previous year due to expenses decreasing more than revenues compared to the previous year.
