Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020, by the Ministry of Finance guiding information disclosure on the securities market; General financial statements for the quarter 1st of 2025 of IDICO-LINCO.

IDICO-LINCO provides the explanation for the profit after tax fluctuation in the income statement for the quarter 1st of 2025 compared the same period last year, as follows:

The profit after tax in the income statement for Quarter 1st of 2025 of IDICO-LINCO decrease by VND 112,032,141,439 compared to the profit after tax in quarter 1st of 2024, representing a 1,126% decrease (Quarter 1st of 2025: VND 9,952,148,506; Quarter 1st of 2024: VND 121,984,289,945)

Reason for the difference:

+ In Quarter 1 of 2025, revenue from real estate transfers amounted to VND 26,191,505,077, significantly lower than the VND 276,640,000,000 recorded in Quarter 1 of 2024. This decrease is primarily due to the fact that, in Quarter 1 of 2024, the Company completed the transfer procedures and recognized revenue from the transfer of a portion of the commercial and service land parcel (14,560 m²) to AEON Vietnam Co., Ltd.

+ In Quarter 1 of 2025, revenue from real estate transfers accounted for 52% of total revenue, compared to 92% in the same period of 2024. The gross profit margin of the real estate business remained high at over 60%, whereas the gross profit margin from other business activities was approximately 10%.

This is the explanation provided by IDICO-LINCO for the profit after tax fluctuation in the income statement for quarter 1st of 2025 compared to the same period last year.
