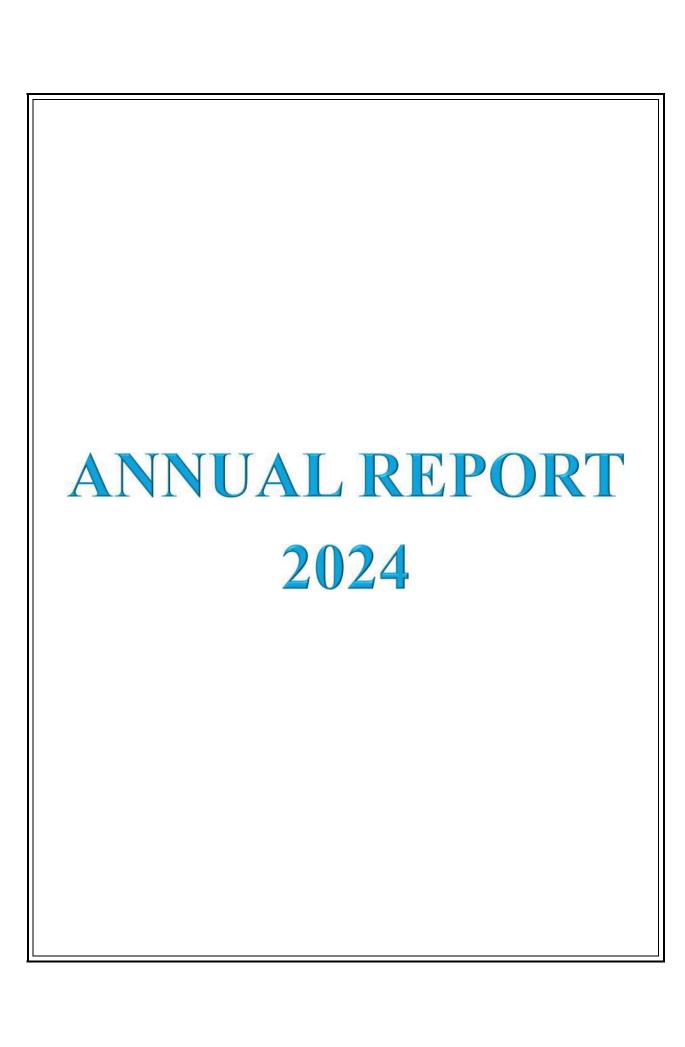

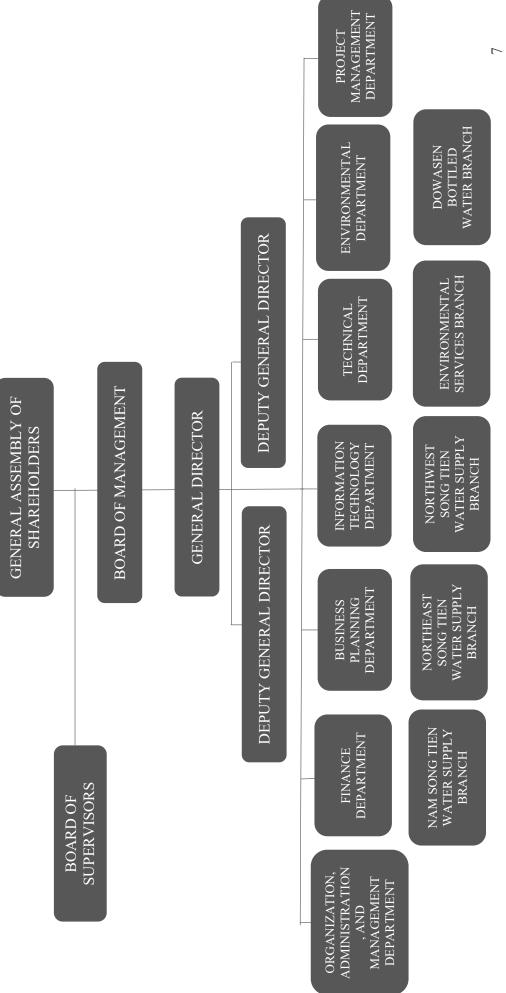


3. Information on Governance Model, Business Organization, and Management Structure

3.1 Governance Model

The Dong Thap Urban Water Supply and Environment Joint Stock Company operates under a governance model that includes: the General Assembly of Shareholders (GAS), the Board of Management (BOM), the Board of Supervisors (SB), the Board of General Directors (GDB), 07 functional departments, and 05 subsidiaries that are financially dependent branches of the Company

4. Development Orientation

a. The Company's Main Objectives

- Successfully implement the business plan approved by the General Assembly of Shareholders (GAS) and the Board of Management (BOM), aiming for an average revenue growth rate of 7.5% compared to the actual performance in 2023, with a pre-tax profit increase of at least 20.52% compared to the 2023 plan.
- Continue to develop investment plans and direct the enhancement of machinery and equipment investment, as well as technological innovation; with a special focus on researching and investing in factory projects, large transmission pipelines, interconnected infrastructure, and water supply networks in the province, in accordance with the Dong Thap Province Master Plan for the period 2021-2030, with a vision to 2050. This aims to support activities that generate revenue and profit for the Company, contributing to attracting investment and fostering socioeconomic development in the Province.
- Direct the company's management activities to remain stable and grow, fulfilling the targets and plans approved by the General Assembly of Shareholders (GAS) annually and over the entire period, balancing business performance with social service functions.
- Actively direct the organization and coordination of the implementation of the plan to transition from groundwater extraction to surface water for supplying water to local residents, in accordance with the timeline and criteria set by the Dong Thap Provincial People's Committee by 2025, with an orientation to 2030, and the Company's annual development investment plan.
- Strengthen forecasting and planning efforts to enhance the Company's financial management capabilities; monitoring, developing capital sources, effectively managing debt, improving asset utilization, and investment efficiency.
- Direct the completion of a comprehensive restructuring of the Company with a focus on streamlining the organizational structure and personnel, reviewing the Company's business activities in each product and service to focus investment and development on core activities with economic and social significance, such as water supply, environmental sanitation, and DOWASEN bottled water, while expanding investment or partnerships in potential fields related to the Company's core business activities, as long as they are not prohibited by law.
- Direct and supervise the reception or sale of water through master meters to rural stations across the province, ensuring a balance of efficiency, customer development, network expansion, improved quality, long-term benefits, and compliance with government regulations.
- Pay more attention to the application of information technology in the efforts to prevent water loss, reducing the water leakage rate in line with the government's general direction.
- Actively direct the application of science and technology, digitalization in customer care, production management, and work processing (regularly upgrading and adding features to systems such as CRM, DOWASCARE, Caresoft, DOWAMETER, DOWASCADA, DweOffice, DOWASEN on smartphone platforms...) to ensure clean water quality and further enhance the Company's product and service quality. Implement a pilot GIS project to manage the water supply network in My Tra commune and My Phu ward, Cao Lanh city. Pilot the use of

- dewatering machines or chlorine neutralization towers at several large plants to improve wastewater treatment efficiency and optimize operational processes in water production.
- Direct the review process and liaise with local authorities to develop plans for registering to participate in tenders, in order to expand the service area for collecting and transporting household waste to other localities within the province.
- Invest in and expand business operations, diversify bottled water products, and actively seek distributors to supply agents in order to achieve revenue growth year by year.
- Build a professional, united, capable, dynamic, and creative workforce. Organize a reasonable
 recruitment plan and training, especially internal training, to enhance skills, work efficiency, and
 timely recruitment according to the Company's business production requirements at any given
 time.
- Focus on promoting awareness of responsibility, discipline among employees, the leadership role of staff, and the ownership role of employee shareholders; strengthen the movement for innovation, technical improvements, and cost-saving practices, while effectively managing expenses to reduce product costs.
- Continue to strengthen the implementation and improvement of the company's operational framework, including focusing on refining regulations, internal governance policies, and mechanisms to ensure the company operates in compliance with legal requirements and enhances labor productivity.
- Continue to implement the directives of the People's Committee of Dong Thap Province, coordinate with relevant departments, sectors, and local authorities to carry out the financial management of assets related to projects funded by state budget sources in accordance with regulations.
- Continue to monitor and direct the implementation of reports and disclosures on the stock market in accordance with the regulations of the Ministry of Finance, the State Securities Commission, and the Stock Exchange, to ensure the legal rights and interests of the Company's shareholders and investors.
- Perform the governance, inspection, and supervision functions of the Company in accordance with the scope of authority and duties of the Board of Management as stipulated in the Company's Charter and applicable laws.

b. Medium and Long-Term Development Strategy

- According to the state-owned enterprise restructuring plan under Decision No. 1479/QD-TTg issued on 29 November 2022, by the Prime Minister of Vietnam, state-owned enterprises in the period of 2022 2025, DOWASEN is included in the plan to maintain state capital until the end of 2025.
- Continue to coordinate with departments, sectors, and local authorities in the implementation of the "Clean Water Supply Plan for Dong Thap Province in the 2021-2025 period," which serves as a basis for the Company to expand the water supply system to rural areas and improve the quality of rural water to match urban water standards.
- Gradually transition to surface water exploitation, limiting the use of groundwater. Increase the proportion of surface water usage to 80% by 2025 and 100% by 2030 to supply water to residents

- in the area in accordance with the roadmap and orientation set by the People's Committee of Dong Thap Province and the Company's annual development investment plan.
- Implement projects to combat clean water loss, enhance the operational capacity of the water supply system, and focus on reducing the loss rate to below 18% by 2025.
- Actively direct the application of scientific and technical advances, digitalization, and digital
 transformation in customer care, production management, and workflow management (such as
 systems like CRM, DOWASCARE, Caresoft, DOWAMETER, DOWASCADA, DWeOffice,
 etc.) to ensure the quality of clean water supply and improve the quality of the Company's
 products and services.

c. Sustainable Development Goals

Environment

- The company is committed to actively protecting the environment and responsibly using resources, which is an essential part of its development strategy.
- Set the goal of optimizing water resources in production, ensuring efficient use, avoiding waste, and minimizing negative environmental impacts.
- Continuously improve technology to minimize material consumption, increase water efficiency, contribute to the protection of natural resources, and preserve valuable assets, while building a trustworthy image in line with the philosophy of "For the community's life."
- Focus on implementing measures to reduce water loss, adhering to the government's guidelines to build an efficient and sustainable water supply and drainage system.

Society and Community

- The company focuses on streamlining its workforce, reviewing all business activities to identify core areas for investment and development, particularly those with economic and social significance such as water supply and environmental sanitation. At the same time, the company expands investment or forms partnerships in potential fields that align with its development direction and comply with legal regulations.
- The company focuses on developing new market entry strategies, expanding and strengthening relationships with potential partners and customers. It invests in upgrading production infrastructure, improving processes to ensure superior product and service quality, which helps increase operational efficiency, ensures sustainable development, provides economic benefits, and enhances brand reputation.
- The company is determined to build and implement a plan to enhance the capacity and work efficiency of its workforce in the 2022-2025 period. The goal is to develop a "Dynamic, Creative, and Effective" workforce, contributing to the successful realization of the company's mission and vision in the new phase.
- Continue to direct the review and establish working relations with local authorities to develop a plan for registering and participating in bidding, expanding the scope of solid waste collection and

transportation services across the province, enhancing operational capacity, and creating sustainable value for the community.

The company's short-term and medium-term policy program

- Development orientation of core business areas, especially water supply and environmental sanitation.
- Develop a plan to expand into areas related to the core business operations.
- Invest in advanced technological solutions to enhance production and management efficiency.
- Enhance the application of digital technology in the operation and monitoring of water supply and drainage systems, as well as waste treatment.
- Enhance the company's image through social responsibility activities and sustainable development.
- Complete welfare policies, professional training, and management to attract talent and improve labor productivity.

5. Risks

Economic Risks

In 2024, the global economic situation continues to evolve with complexity, characterized by numerous risks and uncertainties. Strategic competition between major economies is intensifying, military conflicts are escalating, and the trend towards trade protectionism is increasing, leading the global economy into a state of significant fragmentation. These factors not only affect international trade but also indirectly impact economies dependent on exports and foreign investments, such as Vietnam.

Despite facing many challenges, Vietnam's economy in 2024 still achieved impressive growth. According to the General Statistics Office's report, the national GDP is estimated to increase by 7.09% compared to the previous year. Among this, the water supply, waste management, and wastewater treatment sector grew by 9.43%, contributing 0.06 percentage points to the overall growth. The Industrial Production Index (IIP) of the water supply, waste management, and wastewater treatment sector nationwide increased by 10.7% compared to the same period last year, contributing 0.2 percentage points to the overall growth of the industrial sector. This highlights the importance of the water sector in ensuring socio-economic development, especially in localities with high demand for water supply and wastewater infrastructure, such as Dong Thap province.

In Dong Thap province, the water sector plays a crucial role in improving the quality of life and promoting sustainable development. However, the province is still facing many challenges, particularly the limited budget, which makes it difficult to invest in the drainage and wastewater treatment systems in Cao Lanh City. The lack of a coordinated wastewater connection to treatment plants has led to an increasing risk of environmental pollution. Additionally, rising input costs, including transportation, raw materials, water industry supplies, and electricity consumption, are putting financial pressure on businesses.

As a business operating in the production and distribution of clean water, the company is less directly affected by macroeconomic fluctuations, as water is an essential commodity that the government encourages to develop. However, macroeconomic factors still have an indirect impact on the company's

operations, especially with industrial zones and manufacturing enterprises - key customer groups that account for a large proportion of revenue. When the economy faces difficulties, the demand for water in the industrial sector decreases, affecting the company's revenue.

To ensure stable business operations and maintain sustainable development, the company continues to strengthen management control, optimize operations, and ensure the financial targets set are met. At the same time, the company closely monitors domestic and international economic developments to proactively implement appropriate solutions, minimize risks, and capitalize on opportunities in a highly volatile environment. These efforts not only help the company maintain stable operations but also contribute to improving service quality, ensuring a steady supply of clean water for the community, and contributing to the overall development of Dong Thap province.

Legal risks

DOWASEN, as a publicly traded company listed on the Hanoi Stock Exchange, must adhere strictly to legal regulations in its business operations, including the Enterprise Law, Securities Law, Labor Law, and various other specialized legal documents. Notably, the **Water Resources Law** and **Environmental Protection Law** significantly impact the company's operations, as they provide detailed guidelines on the management, exploitation, and use of water resources, as well as water environmental protection. These legal requirements pose substantial challenges in implementing new projects, particularly the plan to establish land reserves for building surface water plants to gradually replace groundwater, in alignment with the company's sustainable development strategy. The company must ensure compliance with these laws while executing its projects to minimize legal risks and contribute to environmental sustainability.

In addition to legal regulations, government and local policies provide incentives that facilitate business operations and encourage the adoption of environmentally friendly solutions. Based on this, the Company places a strong emphasis on the efficient use of water resources, ensuring sustainable exploitation while fully complying with legal requirements to ensure stable and long-term development.

Industry-specific risks

Environmental risks

Production and daily activities in Dong Thap are facing serious environmental risks, particularly the negative impacts on water resources. The use of chemicals in agriculture and aquaculture, combined with untreated wastewater from industrial zones, is degrading the quality of surface water. This situation not only drives up the cost of clean water treatment but also poses significant challenges to ensuring a safe water supply for both residents and production activities. In addition, the increasingly complex impacts of climate change have led to major risks such as prolonged droughts, riverbank erosion along the Tiền and Hậu Rivers, and increasingly severe saltwater intrusion during dry months.

This phenomenon directly affects the ability to extract and supply clean water, while water pollution and the impacts of natural disasters make water management and treatment more challenging, placing greater pressure on the irrigation systems and water supply infrastructure.

In response to these challenges, the Company consistently prioritizes solutions to enhance disaster prevention and preparedness, including developing response scenarios for saltwater intrusion, in order

to minimize risks during water extraction. Protecting and improving the irrigation system has become a key task to maintain water resource stability and ensure the continuous supply of clean water for both residents and businesses. The Board of Management and the Executive Management closely monitor environmental developments to implement appropriate measures, aiming for sustainable development and a balance between economic growth and water resource protection.

• Risks related to input materials

As a company engaged in water extraction and supply, DOWASEN constantly faces various risks related to input materials, particularly the price fluctuations of materials used in the water treatment process. The rising costs associated with transportation, storage of materials, and electricity consumption have increasingly placed significant pressure on the Company's production and business operations.

Rising costs associated with transportation, material storage, and electricity consumption have placed significant pressure on the Company's business operations. In addition, water pollution also poses potential risks of increasing treatment costs, requiring the Company to implement appropriate solutions to ensure the quality of output water. In response to these challenges, the Company continuously promotes research and the application of science and technology in clean water quality management, aiming to optimize production processes, reduce costs, and maintain operational efficiency. At the same time, seeking innovative solutions to enhance water extraction efficiency and protect the environment remains a key strategic direction, ensuring stable and sustainable operations.

• Water loss risks

In the field of water extraction and supply, water loss is an inevitable issue that significantly affects the Company's operational efficiency and financial performance. Water loss not only increases operational costs but also reduces production efficiency, impacting profitability and the ability to provide a stable water supply to residents. There are several causes of water loss, including both subjective and objective factors. The aging water supply system is at risk of deterioration, pipe breakages during urban infrastructure upgrades, and leaks at water meters and devices at supply stations, especially in rural areas, all contribute to higher water loss rates. Additionally, the shortage of specialized personnel and limitations in leak detection technology make it difficult for the Company to effectively control and reduce water loss.

Recognizing the negative impacts of water loss, the Company has set the goal of reducing water loss rates by implementing a plan for maintaining and repairing the water supply network and upgrading the leak detection system. Replacing water meters and improving the quality of water supply infrastructure are also carried out in a reasonable manner, in line with the Company's financial capacity, to optimize operational efficiency.

Aware of the negative impacts, the Company has set the goal of reducing water loss rates by implementing a plan for maintaining and repairing the water supply network and upgrading the leak detection system. The replacement of water meters and the enhancement of water supply infrastructure

are also carried out in a reasonable manner, aligned with the Company's financial capacity, to optimize operational efficiency.

At the same time, the Company is also focusing on improving the water management system, applying advanced technology to enhance leak monitoring and detect issues in a timely manner. This not only helps improve the efficiency of water resource extraction and usage but also contributes to environmental protection, aiming for sustainable development. These efforts not only minimize financial losses but also bring long-term benefits to the community and ecosystem.

Other risks

In addition to the industry-specific risks in water extraction and supply, the Company also faces uncontrollable risks such as natural disasters, floods, droughts, and epidemics. These factors can disrupt the water supply process, directly affecting business operations and the livelihoods of residents. To proactively respond, the Company maintains a high level of vigilance, regularly inspects equipment systems, and purchases necessary property insurance to minimize losses and ensure that business operations are not interrupted.

Additionally, human resources are a key factor contributing to the Company's development, so ensuring a safe and sustainable working environment is also a top priority. The Company not only provides training and professional development opportunities for employees but also implements supportive policies and offers insurance to create the best conditions for long-term employee retention. These measures help the Company maintain stability and sustainable growth in its business operations.

At the end of 2024, Dowasen recorded a revenue growth of 7.9% compared to 2023, with the domestic water supply segment continuing to be the main revenue source, accounting for 74.13% of total revenue and achieving a growth rate of 9.40%, equivalent to 31.137 million VND.Additionally, revenue from waste collection services accounted for 17.34% of total revenue in 2024, while revenue from construction activities saw the strongest growth rate, at 21.28%, equivalent to an increase of 2.901 million VND. This growth is attributed to the continued focus on urban environmental sanitation activities and the implementation of circular economy practices, such as enhancing the recycling of organic waste and raising awareness about plastic waste management,

Revenue from bottled water grew by 15.34%, with an increase of 1.735 million VND, and its proportion slightly rose from 2.49% to 2.67%, indicating that the company's bottled water product is being better received in the market. Revenue from other services increased by 815 million VND, with its share rising slightly from 1.81% to 1.84%, while revenue from goods sales saw modest growth of 4.98%,

Overall, the revenue situation of Dong Thap Water and Urban Environment Joint Stock Company in 2024 is positive, with significant overall revenue growth. The core business segment of domestic water supply continues to maintain stable growth and remains the main contributor to total revenue.

Although there are varying growth rates across different segments, the overall revenue structure has not changed significantly, with the domestic water supply segment still holding the dominant share,

In 2024, the Company's total operating costs increased from 388,967 million VND (in 2023) to 410,822 million VND (in 2024), an increase of 21,855 million VND, equivalent to 5.62%. This growth rate is lower than the revenue growth rate of 7.90%, which could be a positive sign of cost management efficiency relative to revenue growth.

Labor costs are the largest expense, but they have slightly decreased both in value (-2.494 million VND) and proportion (-1.50%). The share of labor costs in total expenses decreased from 42.67% to 39.79%. This is due to changes in Dowasen's workforce structure during the year. Material costs grew significantly, both in value (14.850 million VND) and proportion (15.19%), causing their share in total costs to increase from 25.13% to 27.41%. The main reason for this increase is the worsening of climate change and surface water pollution, which forced the Company to increase spending on water treatment to ensure water quality. Tool and equipment costs surged by 53.01%, with an increase of 2.411 million VND, raising their share from 1.17% to 1.69%. This is due to investments in water pipeline systems, water stations, and the purchase of specialized vehicles for waste collection and processing. Depreciation of fixed assets increased by 5.92%, with 3.427 million VND, maintaining a stable share of about 14.9%. Additionally, taxes, fees, and charges increased by 89.73%, with 459 million VND. Provisions reversal/addition costs saw a sharp increase of 378.49%, with 2.392 million VND.

Outsourced service costs saw a slight increase of 1.12%, with 129 million VND, while their share decreased slightly from 2.95% to 2.82%. Other cash expenses increased slightly by 1.36%, with 680 million VND, and their share dropped slightly from 12.91% to 12.39%.

Overall, in 2024, despite the increase in total operating costs, some key expense items were still managed effectively, demonstrating the efficiency of cost management efforts, which helped sustain the Company's business growth momentum.

Based on the business results for 2023 and 2024, the Dong Thap Urban Water and Environmental Services Joint Stock Company recorded total revenue and other income of 492,754 million VND in 2024, exceeding the plan by 0.36% and growing by 7.89% compared to 2023. The main source of revenue comes from water supply activities, with clean water consumption reaching 45,733,478 m3 for the year,

The profit from business operations in 2024 reached 57,406 million VND, representing a significant growth of 24% compared to 2023 (46,435 million VND), demonstrating the increasing efficiency of the Company's core business activities. Additionally, profit before tax in 2024 reached 55,414 million VND, exceeding the plan by 10% and growing by 13% compared to 2023. Net profit after tax in 2024 reached 49,435 million VND, exceeding the plan by 12% and growing by 15% compared to 2023, proving the positive business performance of Dowasen in the year,

Overall, 2024 can be considered a successful year for the Company, as it exceeded the plan in most of the key targets for revenue and profit, while also achieving significant growth compared to 2023. With this positive result, the outlook for the Company's next year can be considered optimistic,

d. Human Resources Policy

Organizational work:

The company continues to implement a comprehensive restructuring towards streamlining, ensuring that the organizational structure and human resources operate more effectively and flexibly. This process involves a thorough review of the organizational structure, reassessing the company's business activities for each product and service, thereby focusing on investing in high-profit areas while cutting down on ineffective costs.,

The company's management structure consists of the Board of General, 07 functional departments, and 05 branches under its direct control. As at 31 December 2024, the total number of employees in the company is 795, including 696 permanent employees and 99 fixed-term contract employees,

Human Resources Management:

The total number of managers and employees at the Company at the end of 2024 is 800 people (178 women), an increase/decrease of 9 people compared to the end of 2023. The Company continues to organize and implement personnel transfers, appointments, training, and development programs to gradually enhance the workforce and improve the management staff in the new situation,

DOWASEN's corporate culture continues to be promoted to create a professional working environment that encourages creativity and dedication from employees,

Recruitment will be carried out strictly, fairly, transparently, and openly, ensuring the attraction of highly qualified personnel who meet the required competency criteria in line with the company's development orientation,

Training work:

In order to enhance the capacity and work efficiency of the staff, the company will continue to implement specialized training programs for each department, supporting the restructuring process, while also improving both professional skills and work management skills,

The company will continue to organize training sessions, workshops, and skill development programs for its staff, aiming to enhance work quality and performance. The training programs will include professional seminars, short-term courses on management, tax policies, and the implementation of

decrees, ensuring that the workforce is always up-to-date with new knowledge and able to adapt to changes in the business environment,

At the same time, the company is developing a capacity-building plan, equipping employees with the necessary skills to cope with unforeseen circumstances that may arise. This is one of the key solutions to ensure that the workforce not only works efficiently but also contributes to the long-term sustainable development of the company,

Wage management:

The company implements the salary policy based on the state's salary table, ensuring fairness, transparency, and alignment with the actual operational situation. The salary and bonus regulations are designed to encourage employees' contributions, while also fulfilling the obligations for social insurance (SI), health insurance (HI), and unemployment insurance (UI) according to current laws and policies,

In addition, the company develops a competitive salary and bonus policy, especially for employees with high competence and experience, aiming to attract and retain talented personnel, create motivation for work, and increase long-term commitment to the company,

In 2024, the average income of employees reached VND 16,390,000 per person per month, an increase/decrease of 8.1% compared to the annual plan. The company continues to adjust the salary levels of staff based on productivity and work performance to ensure timely and full salary payments, in line with business results,

Additionally, the company places great emphasis on building a flexible and timely reward policy to motivate employees to fully unleash their personal potential, enhance work performance, and make positive contributions to the sustainable development of the company. These compensation schemes not only encourage a strong work ethic but also help establish a professional, dynamic, and fair working environment,

Employee Benefits Policy:

In order to provide the best working conditions and ensure the rights and benefits of employees, the Company always focuses on developing a comprehensive welfare policy, ensuring fairness, transparency, and compliance with legal regulations,

- Allowances: Employees are entitled to various allowances such as lunch allowance, transportation allowance, phone allowance, etc., to help reduce the burden of living expenses and provide better support during their work process,
- Insurance: The Company fully complies with the insurance policies as per legal regulations, including Social Insurance (SI), Health Insurance (HI), and Unemployment Insurance (UI), to ensure social security for employees. Additionally, the Company has a policy to support the purchase of health insurance for employees and their families, ensuring that workers can focus on their duties while having access to better healthcare,
- Leave: Employees are entitled to 12 days of annual leave, in addition to the public holidays and New Year holidays as prescribed by law. Moreover, the Company provides flexible arrangements, allowing

employees to utilize their leave days in a way that suits their personal needs without affecting the overall work performance,

3. Investment Situation and Project Implementation

a. Investment Items

The company plans to invest in development with a preliminary estimated total investment of VND 147,945 million, specifically:

- i) Investment in the construction of source facilities: VND 26.500 million,
- ii) Investment in the construction of water supply pipelines: VND 103.300 million,
- iii) Acquisition of water supply stations: VND 1.680 million,
- iv) Procurement of specialized vehicles for waste collection, transportation, and treatment: VND 10.010 million,
- v) Procurement of machinery and equipment for water production: VND 6.455 million,

Depending on each specific period, the Board of Management and the Executive Board of the Company will determine the priority order of each project, as well as adjust and supplement the 2025 investment and development plan to align with the actual situation and the roadmap for water source transition in each locality, in accordance with the provincial water supply development plan for the 2021–2025 period,

In addition, in implementing the Provincial Water Supply Plan for the 2021–2025 period, the Company will also organize the takeover of rural water systems and make procurements at appropriate times throughout the year, with the aim of fulfilling and exceeding the 2025 business and production plan as well as the 2022–2027 period targets,

c. Other long-term financial investments:

The Company's capital is mainly focused on key areas and tasks assigned by the provincial People's Committee, such as water supply, environmental sanitation, production and business of bottled and jarred water, etc. Investments outside the Company's core business areas are insignificant and do not affect its main production and business activities. Currently, the Company only invests in purchasing shares of the Water and Environmental Consulting Joint Stock Company of Ho Chi Minh City, with an amount of VND 84,040,000 (10,000 shares), and receives annual dividends,

• Liquidity indicators

In 2024, the Company's liquidity ratios have all changed compared to the same period last year. The current ratio continues to improve, increasing from 1.05 times in 2023 to 1.56 times in 2024. This ratio indicates that the Company's ability to use current assets to settle short-term liabilities has strengthened, showing that DOWASEN has sufficient current assets to cover its short-term debts. On the other hand, after excluding inventories, the quick ratio decreased from 0.80 times in 2023 to 0.61 times in 2024. The reason for this decline is the increase in receivables, which has impacted the Company's quick liquidity. This suggests that the Company needs to closely monitor the quality and recoverability of short-term receivables in order to minimize cash flow risks and improve liquidity efficiency in the future,

• Capital structure indicators

"As of the end of 2024, the Company's capital structure indicators have slightly decreased compared to the previous year. In 2024, the Company recorded a 0.61% decrease in total assets (equivalent to a reduction of VND 6,508 million) and a 5.71% decrease in shareholders' equity (equivalent to a reduction of VND 19,255 million). Meanwhile, the Company recorded a 3.62% decrease in total liabilities (equivalent to a reduction of VND 26,143 million). Accordingly, the changes in various items were uneven, leading to a slight decrease in the Company's capital structure indicators compared to 2023. Specifically, the debt-to-total assets ratio decreased from 0.67 times to 0.65 times, and the debt-to-equity ratio decreased from 2.06 times to 1.88 times. The main reason for the reduction in the debt ratio this year is that the Company has fully fulfilled its obligations to repay both short-term and long-term loans when due,

In 2024, the inventory turnover ratio continued to increase from 9.48 times to 11.27 times, confirming that Dowasen's inventory management efficiency has improved, with inventory being sold faster. This increase reflects that the Company has optimized its inventory management and consumption processes, helping to reduce storage costs and enhance business efficiency,

In addition, the total asset turnover ratio also continued to increase slightly from 0.42 times to 0.46 times, indicating that Dowasen has utilized its assets more effectively to generate revenue in 2024. This demonstrates that the Company has made better use of its available resources, from short-term assets to long-term assets, to achieve higher revenue without significantly increasing its assets

• Profitability indicators

"In 2024, despite facing many economic fluctuations, the Company's profitability indicators saw significant growth compared to the previous year. The main reason for this is that the Company operates in the water supply and environmental services sectors, which are essential services for the daily lives of the people. In 2024, the net profit and operating profit recorded strong increases of VND 49,452 million and VND 57,406 million, respectively, corresponding to a 115% growth in net profit and a 124% growth in operating profit. As a result, all of the Company's profitability indicators have grown compared to 2023. Specifically, key ratios such as ROS (net profit over revenue from sales and services), ROE (net profit over shareholders' equity), ROA (net profit over total assets), and operating profit margin (operating profit over revenue) have all increased. In 2024, these ratios reached 10.12%, 13.55%,

4.63%, and 11.74%, respectively, reflecting increases of 0.78%, 1.44%, 0.58%, and 0.79% compared to the same period last year,

6. The Company's Environmental and Social Impact Report

a. Management of raw material sources

To ensure that water quality meets the standards set by QCVN 01-1:2018/BYT, the Company applies water disinfection methods using chlorine and other compounds. Maintaining a residual chlorine level in the water is essential to prevent microbial contamination during transportation through the water supply network, ensuring hygiene safety for users. However, water treatment chemicals account for a large proportion of production material costs, necessitating the optimization of raw material usage and management to balance operational efficiency with production costs,

In order to minimize risks and ensure the quality of raw material sources, the Company focuses on optimizing the chemical usage process, establishing reasonable norms to reduce costs while maintaining stable water quality. At the same time, strict control over chemical usage helps the Company reduce waste, enhance operational efficiency, and maximize profits,

In addition, the Company places special emphasis on selecting reliable raw material suppliers to ensure the quality of input products and avoid risks associated with poor-quality materials that could affect the environment and public health. Collaborating with reputable suppliers not only helps maintain stability in the supply chain but also contributes to improving the quality of clean water, meeting strict standards for safety and environmental protection

b. Energy consumption

The company primarily uses electricity to operate the water treatment system, pumps, and provide lighting for the factory and office. Efficient management and use of electricity not only ensure stable production operations but also play a key role in optimizing production costs and increasing business efficiency,

Energy conservation is one of the key objectives the Company always focuses on in order to reduce operating costs and enhance resource efficiency. Therefore, the Company regularly organizes training courses to improve employees' skills in using electricity safely, efficiently, and economically, thereby contributing to optimizing production activities and protecting the environment,

The total electricity cost for the year 2024 is VND 48,139 million, of which:

- Electricity for production: VND 47,715 million
- Lighting electricity: VND 424 million

In the near future, the Company will continue to implement solutions to improve energy efficiency, apply modern technologies to the operating system to minimize electricity waste, with a focus on sustainable development and ensuring long-term profitability,

c. Water consumption

Water is not only a raw material but also the main product in the Company's production activities. Therefore, effectively reusing water plays a key role in the sustainable development strategy. The Company applies advanced technology combined with a professionally designed piping system, which helps optimize water usage and minimize waste during the production process,

In addition, the Company regularly inspects and maintains the piping system to prevent leaks, damage, or water loss due to impacts. Strict control of the water supply system not only improves operational

efficiency but also helps reduce production costs, ensuring that water is always used in a rational and economical manner. This is always considered a core value and serves as the foundation for the Company's business and production activities,

d. Compliance with environmental protection laws

The company has invested in machinery, tools, and expanded the Da Dap landfill in Sa Dec to enhance waste collection, transportation, and treatment capabilities, ensuring compliance with environmental regulations and minimizing the impact on the community. A well-designed shielding system has been implemented to control pollution, reduce leakage, and ensure safe operations,

Annually, the Company prepares an environmental impact assessment report to ensure that the clean water production technology meets the required standards. At the same time, the Company works closely with environmental monitoring agencies to conduct regular inspections and evaluations, maintaining transparency in its operations,

e. Employee-related policies

The company implements a democratic policy, prioritizing the health and welfare of employees. Workers are provided with protective gear, participate in social insurance and health insurance, and receive full salaries, bonuses, benefits, and vacation leave as per regulations,

The company is committed to treating employees fairly, promoting rewards and recognition, supporting social welfare, and creating career development opportunities. This helps employees enhance their skills, build long-term commitment, and contribute effectively to the company's growth,

f. Reports related to responsibilities towards the local community

The company not only focuses on business operations but also upholds its social responsibility, contributing to the improvement of the community's quality of life. The company takes over and operates water supply stations as requested by local authorities, expands the service area, and supports water pricing for poor and near-poor households, ensuring access to clean water for all groups,

In addition, the company closely collaborates with the local authorities of Dong Thap Province in disease prevention, environmental protection, and the implementation of community projects. Furthermore, the company actively participates in and supports cultural, festival, and sports events, contributing to enhancing its image, reputation, and connection with both the local community and visitors, showcasing its role as a responsible corporate entity for the community,

g. Reports related to green capital market activities in accordance with the guidelines of the State Securities Commission

Currently, the Company does not engage in green capital market activities. However, DWS closely monitors information regarding this activity and will actively participate when specific guidelines are provided by the State Securities Commission,

III. Report and evaluation by the Board of Management

1. Evaluation of business operation results

a. Overview analysis of the Company's activities in 2024

In 2024, despite facing many challenges, the Company successfully achieved its targets and tasks thanks to the attention and support from various levels and sectors in Dong Thap Province, along with the unity and efforts of the entire leadership and staff,

The results achieved this year have laid the foundation for investing in the development of a centralized water production plant network, expanding the customer base, and increasing consumption output. The positive economic performance of 2024 not only affirms the Company's steady growth but also serves as motivation for the team to continue striving toward stable and sustainable development in the years to come,

Advantages:

- The company receives attention, support, and favorable conditions from the People's Committee of Dong Thap Province, as well as from various departments and agencies, which helps sustain and develop its production and business activities.
- The water supply sector has experienced stable growth; environmental activities have received attention, and there have been investment initiatives to purchase equipment for waste collection, which gradually improves service quality. The production and business of bottled and jarred water has grown well.
- The number of customers using online payment has increased, enhancing the rate of cashless payments in line with the government's policy, which contributes to saving time and costs, as well as improving the management of receivables.
- The company has received preferential loans from the Provincial Development Investment Fund for investment in expansion, which helps the company expand its water supply coverage and purchase equipment for business service, meeting the assigned targets.
- Due to the nature of the water industry, there is little competition, so business activities in this sector always experience stable growth,

Difficulties:

- The process of sealing wells in accordance with the policy of transitioning from groundwater to surface water, as directed by the People's Committee of the Province, has not been timely implemented due to the delay in constructing surface water plants. As a result, the volume of water supplied has decreased, impacting the production targets.
- The water loss rate in rural areas remains high, mainly due to the vast coverage area and the low-quality materials used in the pipeline network, which often leads to frequent leaks and breaks.

This requires significant time, labor, and cost for repairs. Additionally, water loss combined with interruptions in water supply due to repairs has significantly reduced the amount of water provided.

- The company is in the process of transitioning from exploiting groundwater sources to surface
 water sources in certain areas. However, this has created difficulties in finding suitable land for
 investment and the construction of replacement plants as planned. Moreover, due to the higher
 risk of surface water contamination, treatment costs must be increased to ensure the best possible
 water quality.
- The demand for household water supply services within urban areas is gradually reaching saturation. Therefore, to expand the business, the company primarily relies on investments in developing water supply networks in rural areas as required by local authorities. However, due to the low population density and high investment costs in these areas, the effectiveness of this expansion is not high, and the capital recovery process is slow.
- In urban development projects, when road improvement or expansion projects take place, the company's water pipelines are often affected, forcing the company to relocate and reconnect services for each household. The costs for these activities are relatively high.

Although the environmental services sector has grown, local authorities continue to develop waste collection routes to rural areas, which generates many additional costs while the revenue does not correspond. Some areas have not been supportive in resolving customer debt issues and have not actively cooperated in encouraging citizens to register for sanitation services, leading to issues like littering and revenue loss for the company. Additionally, the company has to participate in tenders, with many competitors, making it difficult to maintain and expand operations. Along with rising costs, such as the overload at the two main landfills (Đập Đá and Sa Đéc) and the increase in fuel prices, this affects the stability and efficiency of operations.

Although the bottled and jarred water sector has grown, the factory space is still limited. The company has to compete with many similar low-cost products, and expanding into rural areas faces challenges due to price constraints. The market is still mainly confined to urban areas,

2. Company's Achievements:

In 2024, the company's business expansion primarily focused on developing new customers in rural areas, which contributed to increasing the number of households using water supply services to 9,000 households. The number of customers using waste collection and transportation services also saw a strong increase, with an additional 11,600 households. This growth, along with the increased capacity

of several water treatment plants, led to a rise in revenue from water supply and waste collection services compared to the same period last year. Additionally, revenue from other activities such as bottled water production, septic tank cleaning, and tree care services also experienced good growth. This has contributed to an overall increase in revenue, which in turn has led to higher post-tax profit for the company.

As of the end of 2024, the company's total assets decreased slightly by 0.61% (equivalent to 6,508 million VND), from 1,071,554 million VND in 2023 to 1,065,046 million VND in 2024,

Current Assets

Current assets increased by 21.90% (equivalent to 31,869 million VND), from 145,526 million VND to 177,395 million VND. The proportion of current assets in total assets also rose from 13.58% to 16.66%. This indicates that the company is increasingly focusing on assets with high liquidity.,

Short-term receivables saw a significant increase of 58.75% (equivalent to 32,492 million VND), which was the main factor contributing to the growth of current assets. The receivables primarily stemmed from water supply service collections. Short-term financial investments rose by 33.33% (equivalent to

3,500 million VND) due to the company making a 12-month term deposit at the bank during the year. Other current assets increased by 556.93% (equivalent to 5,280 million VND), accounting for 0.58% of total assets. Inventory decreased by 29.24% (a reduction of 10,311 million VND), indicating improved inventory management. Meanwhile, cash and cash equivalents only saw a slight increase of 2.09% (equivalent to 908 million VND), with no significant change,

Non-current Assets

Regarding non-current assets, there was a slight decrease of 4.14% (equivalent to 38,377 million VND), from 926,028 million VND to 887,651 million VND. The proportion of non-current assets in total assets decreased from 86.42% to 83.34%,

Key changes in the items include a 5.73% decrease in long-term work in progress, down by 27,381 million VND. The reason for this is that the basic construction investment projects have been completed according to the 2024 development investment plan. Specifically, 1/5 of the projects have been accepted and put into use, while 3/5 of the projects have been completed. Regarding the procurement and handover of water supply stations, the company has completed the purchase of 3/5 of the vehicles and received 7/11 water supply stations. At the same time, the company has accepted and transferred the water supply stations as planned. Fixed assets decreased slightly by -3.05% (equivalent to -13,023 million VND), while other non-current assets increased by 9.44% (equivalent to 2,026 million VND), with no significant changes. The long-term financial investment represents the capital contribution to the Water Supply and Environmental Consulting Joint Stock Company, with an ownership stake and voting rights of 1.25%, with no changes during the year.

Overall, in 2024, the company's asset structure has undergone adjustments, particularly with the increased proportion of current assets, indicating the company's focus on prioritizing liquidity and its ability to meet short-term obligations. However, short-term receivables also need to be closely monitored regarding their quality and collectability to minimize the risk of bad debts in the future,

The company's total liabilities decreased by 3.62% (equivalent to 26,143 million VND), from 721,491 million VND in 2023 to 695,347 million VND in 2024, indicating that the company has reduced its liabilities burden during the year,

Short-term Liabilities Structure

Short-term liabilities decreased by 18.21% (equivalent to 25,244 million VND), from 138,647 million VND to 113,403 million VND. The proportion of short-term liabilities in total liabilities also decreased from 19.22% to 16.31%. This indicates that the company has reduced short-term payment pressure. Key items with significant fluctuations include:

Short-term borrowings and financial lease liabilities decreased by 48.94% or 30,675 million VND, as the company reduced short-term loans. Advances from customers decreased by 97.98%, equivalent to a decrease of 2,767 million VND. Payables to suppliers increased significantly by 48.88%, while taxes and other payables to the state rose by 22.35%. Payables to employees increased by 24.27% due to the increase in the number of employees during the year,

Short-term liabilities decreased significantly by 18.21% (equivalent to 25,244 million VND), from 138,647 million VND to 113,403 million VND, and the proportion of short-term liabilities in total liabilities decreased from 19.22% to 16.31%, reflecting the company's reduction in short-term payment pressure. Key items with significant fluctuations include:

Long-term Liabilities Structure

Long-term liabilities decreased slightly by 0.15% (equivalent to 900 million VND), from 582,844 million VND to 581,944 million VND. However, the proportion of long-term liabilities in total liabilities increased from 80.78% to 83.69% due to the more significant reduction in short-term liabilities. Specifically, other long-term payables decreased slightly by 1.17%, while long-term borrowings and financial lease liabilities increased by 0.49% with no significant change. Long-term provisions, which arose during the year, increased by 749 million VND. The Science and Technology Development Fund increased by 23.50%, equivalent to 3,720 million VND.

Overall, during the year, the company successfully reduced its total liabilities, which is a positive signal for financial management. Although long-term liabilities decreased slightly in value, the proportion of long-term debt in total liabilities increased significantly due to a more substantial reduction in short-term liabilities. This may help reduce short-term payment pressure but will extend the company's debt obligations in the future.

3. Improvements in Organizational Structure, Policies, and Management

In the past year, the company has continued to maintain its organizational structure as it recognizes the effectiveness it brings to operations. Management policies have also been consistently maintained,

improved, and supplemented, while continuing to provide strong support for the executive work of the Board of General Directors.

- Based on the evaluation, the CEO and the Executive Board have fully and seriously implemented the Resolutions and Decisions of the Board of Management; complied with the policies and laws of the State in managing and operating the Company; and ensured the rights of shareholders and employees as well as the overall operational efficiency of the Company.

- Focus on building a professional workforce, strengthening responsibility and labor discipline to ensure stable and sustainable operations.

b. Activities of the Board of Supervisors

Evaluation of the Board of Supervisors's Activities for the Year:

a) Supervisory Activities of the Board of Supervisors Regarding the Board of Management, the Board of General Directors and Shareholders

In 2024, based on the assigned responsibilities, the members of the Board of Supervisors carried out the inspection and supervision of the Company's activities as follows:

- Supervise the implementation of Decision No. 1479/QĐ-TTg dated 29 November 2022 of the Prime Minister approving the Plan to restructure state-owned enterprises and state-owned enterprises under provincial management for the period 2022-2025, the Company is in the case of maintaining the state capital portion until the end of 2025.
