The after-tax profit in the company's Q1/2025 financial statements reached VND 4.37 billion (a decrease of VND 0.74 billion), equivalent to a 14.53% decrease compared to Q1/2024.

## Reason:

Although revenue and gross profit increased during the period, general and administrative expenses increased VND 1.49 billion (equivalent to 30.85%) compared to the same period last year. The increase was mainly due to salary expenses, employee welfare, and training costs.

The above reasons have caused the profit after corporate income tax on the financial statement of the first quarter of 2025 to decrease by 14.53% compared to the same period in 2024.
