Viet Tri Chemical Joint Stock Company has prepared the Financial Statements for the first quarter of 2025 with the key figures as below:

According to the Financial Statements for the first quarter of 2025, profit after tax increased by 55.8%, equivalent to VND 5.8 billion, compared to the same period in 2024. The Company provides the following explanation:

The primary reason for the profit growth is the increase in revenue. In the first quarter of 2025, net revenue rose by 14.8%, equivalent to VND 50.6 billion. This growth was driven by higher prices compared to the same period in 2024. Specifically, the selling prices of liquid caustic soda products increased by 22-26%; these chlorine-based products such as various types of Sodium Hypochlorite (Javel) rose by 15-20%, both liquid and powder Poly Aluminium Chloride (PAC) climbed by more than 30%.

At the same time, the prices of input materials surged significantly, by up to 20%, affecting overall business results. Nevertheless, prompt adjustment of pricing strategies, playing a role in improving operational efficiency.
