Re: Explanation related to QI/2025 Financial Report

To:

During the production and business activities in QI/2025, the after-tax profit of Nha Be Water Supply Joint Stock Company (NBW) reached VND11,852 million, an increase of VND4,863 million (+69.59%) compared to the same period last year, due to the following reasons:

- 1. Total Revenue and other income in QI/2025 reached VND222,487 million, an increase of VND2,289 million (+1.04%) compared to the same period last year:
- ❖ Water sales revenue decreased by VND3,771 million (-1,73%) due to lower sales volume 813,649m³. Though the average selling price increased from VND12,175.55/m³ to VND 12,533.59/m³ (+VND358.03/m³).
- ❖ Revenue from installation and relocation of water meters increased by VND976 million (+490.59%).
- * Revenue from selling water supply materials increased by VND 5,724 million due to the liquidation of water supply materials during the period.
- Other revenues decreased by VND640 million, mainly due to the bottled water business (Sawanew) ceasing operations as of December 31, 2024.
- 2. Total expenses in Q1/2025 were VND207,530 million, a decrease of VND3,835 million (-1.81%) compared to the same period last year:
- ❖ Cost of goods sold decreased by VND3,874 million (-2.56%), including:
- The cost of purchasing clean water decreased by VND4,444 million (-2.95%). due to a drop in purchase volume 442,039 m³, the non-revenue water rate increased from 11.54% to 13.71% anh the unit purchase price increased from VND7,106.15/m³ to VND7,276.70/m³.
- Cost of Sawanew water decreased by VND316 million.
- Other costs increased by VND886 million, mainly due to the increase in meter installation and relocation activities.
- ❖ Selling expenses decreased by VND148 million compared to the same period last year:
- Water loss prevention expenses increased by VND1,367 million due to underground leak detection and repair costs incurred during the period.
- Regular and test water meter replacement costs decreased by VND 1,037 million (-29.97%).
- Other selling expenses decreased by decreased by VND 478 million.



- ❖ Administrative expenses increased by VND187 million, mainly due to an increase in miscellaneous cash expenses.
- 3. Corporate income tax increased by VND1,261 million due to the increase in pre-tax accounting profit (the liquidation of water supply materials during the period).
