1. In separate financial statement:

The net Profit after tax in 1th Quarter 2025 recorded a loss 12.940.039.409 VND and the loss had been increased 12.940.039.407 VND compared to the same period of 2024

- The decline in Gross profit margin was attributed by lower retail prices that because a constantly decreased on the price compared to the beginning of the period, resulting in the inventory loses
- The financial investment income decreased due to a reversal of financial investment provision that related to PETEC Logistics JSC in the first quarter of 2024.

- The administrative expenses slightly decreased compare to the same period last year due to a provision for doubtful debts related to ORIENT OIL AND GAS JSC (ORIENT OIL) recorded in the first quarter 2024.

2. In consolidated financial statement:

The after-tax loss for the first quarter 2025 was VND 12.536.377.497, an increase of VND 12.425.073.877 in losses compared to the same period last year, mainly due to the aforementioned fluctuations from the parent company.
