The Board of Directors of Song Da 7.02 Joint Stock Company reports to the General Assembly of Shareholders at the Annual General Meeting 2025 on the organization of personnel within the jurisdiction of the General Assembly of Shareholders for the 2020-2025 term and the personnel organization for the 2025-2030 term as follows:

# I. Personnel Organization within the Jurisdiction of the General Assembly of Shareholders for the 2020-2025 Term

Pursuant to the Company's Charter at the 2020 Annual General Assembly, the personnel organization within the jurisdiction of the General Assembly of Shareholders for the 2020-2025 term is as follows:

- The number of members of the Board of Directors: 03 members
- The number of members of the Supervisory Board: 03 members

In accordance with Resolution No. 09 CT/NQ-DHDCD at the Annual General Assembly held on April 17, 2024, the personnel organization within the jurisdiction of the General Assembly of Shareholders for the 2020-2025 term is as follows:

# 1. Board of Directors and Company Leadership:

- Mr. Nguyen Huu Nhuan Chairman of the Board of Directors
- Mr. Nguyen Huu Doanh Member of the Board of Directors
- Mr. Pham Van Toan Member of the Board of Directors, cum General Director

# 2. Supervisory Board:

- Mr. Nguyen The Hoang Head of the Supervisory Board
- Mr. Nguyen Cao Son Member of the Supervisory Board
- Mr. Nguyen Van Long Member of the Supervisory Board

On May 8, 2024, Mr. Pham Van Toan, a member of the Board of Directors and the General Director of the Company, submitted a resignation letter for personal reasons. Based on the Company's business situation, on May 9, 2024, the Board of Directors held a meeting and approved the resignation letter of Mr. Pham Van Toan from the position of Member of the Board of Directors and General Director. The resolution No. 17/NQ-HĐQT dated May 9, 2024, was issued, agreeing to relieve Mr. Pham Van Toan from the position of General Director of Song Da 7.02 Joint Stock Company. Regarding Mr. Pham Van Toan's resignation from the position of Member of the Board of Directors, his request was accepted according to his personal wish. However, until the General Assembly of Shareholders is organized to elect a new member for the Board of Directors, and since the 2020-2025 term is about to end, the Board of Directors agreed to temporarily leave 1/3 of the Board of Directors vacant until new personnel are appointed. This decision will be presented to the General Assembly of Shareholders to elect the Board of Directors as per regulations.

On May 8, 2024, Mr. Nguyen Cao Son, a member of the Supervisory Board, submitted a resignation letter to step down from his position as a member of the Supervisory Board to focus on other work. Based on the actual conditions of the Company, on May 9, 2024, the Board of Directors and the Supervisory Board held a meeting and approved Mr. Nguyen Cao Son's resignation letter. Resolution



No. 17/NQ-HĐQT was issued, accepted Mr. Nguyen Cao Son's resignation according to his personal request. However, since there are no shareholders or shareholder groups nominating or opposing candidates, and with the 2020-2025 term about to end, the Board of Directors and the Supervisory Board agreed to temporarily leave 1/3 of the Supervisory Board vacant until new personnel are appointed. This decision will be presented to the General Assembly of Shareholders to elect the Supervisory Board as per regulations.

On May 9, 2024, Song Da 7.02 Joint Stock Company received Official Letter No. 28/CV-TCNS from Song Da 7 Joint Stock Company, appointing Mr. Nguyen Cao Son as the representative of the capital contribution of 41,774,060,000 VND, equivalent to 4,177,406 shares (representing 34.8% of the charter capital) of Song Da 7 Joint Stock Company in Song Da 7.02 Joint Stock Company. At the same time, they nominated him for election to the Board of Directors of Song Da 7.02 Joint Stock Company and recommended his appointment as the Chief Executive Officer of Song Da 7.02 Joint Stock Company.

On May 9, 2024, the Board of Directors of the Company issued Resolution No. 17/NQ-HĐQT, appointing Mr. Nguyen Cao Son as the CEO of Song Da 7.02 Joint Stock Company.
