1. Revenue from Sales:

Net revenue in both the separate and consolidated financial statements for Q1 2025 remained relatively stable compared to the same period in 2024. This is primarily due to a 30%–50% increase in sales volume of finished products during the period. Additionally, the Company reduced its trading business activities.

2. Net Profit After Tax:

The increase in profit after tax in both the parent company and consolidated financial statements is attributable to the following factors:

- The Company optimized inventory management, maintained stable input material prices, and significantly reduced production costs, resulting in a lower cost of goods sold.
- The volume of finished products sold by the Company and its subsidiaries increased, thereby improving net revenue and gross profit.

Profit contributions from subsidiaries and associated companies recorded a significant increase compared to the same period in the previous year.
