The reason for the difference is that in the first quarter of 2025, the Company recorded revenue from office leasing activities at 143 Tran Phu building and Song Da Ha Dong building and building management services.
- * Profit before tax in the first quarter of 2025 is: VND 269,269,342 compared to profit before tax in the same period last year: VND 369,240,758. The reason for the difference is that in the first quarter of 2025, the Company recorded revenue from building services, office leasing and building management services.

* Profit after tax in the first quarter of 2025 is: VND 268,253,170 compared to profit after tax in the same period last year: VND 342,682,555. The reason for the difference is that in the first quarter of 2025, the Company recorded revenue from building services, office leasing and building management services.

B. Parent Company Report (Summary Report):

- * Revenue fluctuations: Total sales revenue in the first quarter of 2025 is: VND 6,729,673,980 compared to total sales revenue in the same period last year: VND 6,479,951,873. The reason for the difference is that in the first quarter of 2025, the Company recorded revenue from office rental and other operating revenue.
- * Profit before tax in the first quarter of 2025 is: VND 194,206,243 compared to profit before tax in the same period last year: VND 166,981,914. The reason for the difference is that in the first quarter of 2025, the Company recorded revenue from building services, office rental and building management services.
- * Profit after tax in the first quarter of 2025 is: 194,206,243 VND compared to profit after tax in the same period last year: 166,981,914 VND. The reason for the difference is that in the first quarter of 2025, the Company recorded operating revenue, office rental and interest expenses.
