I. The differances in profit after corporate income tax between 01/04/2025 - 30/06/2024 compared to the same period of the previous year:

The profit after tax during the accounting period from April 1, 2024 to June 30, 2024 increased by 1.578.668.571 VND, compared to the same period due to the following primarily reasons:

- Gross profit from sales and services decreased by VND 2.800.682.493, primarily due to a decrease in revenue from the processing activities
- 2. Financial expenses decreased by VND 1.523.269.477 due to a reduction in loan principal and interest rates compared to the same period
- 3. Other income increased by VND 616.700.712 due to a reduction of 2024 land lease according the decree no.87/2025/NĐCP.
- 4. Other expenses decreased by VND 1,789,926,484 because there was an additional payment for land lease from previous years prior to 2024 during the accounting period from April 1, 2024 to June 30, 2024,

Other items changed but did not significantly affect the Company's profit after tax for the accounting period from April 1, 2025 to June 30, 2025, compared to the same period last year.

In summarizing the above items, the profit after tax for accounting period from April 1, 2025 to June 30, 2025 increased by VND 1.578.668.571, compared to the same period last year

II. Profit after corporate income tax between 01/04/2025 - 30/06/2025 is 846.961.950 VND

Due to a decline in both domestic and export market demand, revenue decreased, leading to a reduction in gross profit. However, as outstanding balances and interest rates fell, leading to financial expenses also decreased. The above are the main reasons why the Company's business results for 2025 second quarter showed a profit of VND 846,961,950
