The 2nd quarter of 2025 Financial Report, prepared on July 20, 2025, and the 2nd quarter of 2024 Financial Report show a discrepancy of 10%. The company would like to explain as follows:

The after-tax profit for the 2nd quarter of 2025 is 77,633,287,382 VND, an increase of 39% compared to the same period last year.

Due to the following reasons:

- Revenue in the 2nd quarter of 2025 increased by 109% compared to the 2nd quarter of 2024 due to a 94% increase in consumption volume. The selling price of yellow phosphorus products increased by 10% compared to the same period last year, while other costs remained relatively stable. As a result, the company's after-tax profit increased by 39% compared to the same period last year

The cumulative after-tax profit for the first 6 months of 2025 increased by 39% compared to the same period last year, due to the following reasons:

- The cumulative revenue for the first 6 months of 2025 increased by 37% compared to the same period in 2024, due to a 26% increase in consumption volume, particularly a 45% increase in export volume, and an average selling price of yellow phosphorus products rising by 10% compared to the same period last year. As a result, the company's after-tax profit for the first 6 months of 2025 increased by 39%.
