Pursuant to the provisions of Circular No. 96/2020/TT-BTC dated 16 November 2020 of the Ministry of Finance guiding information disclosure on the stock market, Bien Hoa Building Materials Production and Construction Joint Stock Company (securities code: VLB) hereby present our explanation below:

After-tax profit presented in the Interim Income Statement for the first 6 months of 2025 varies by more than 10% compared to that of the same period in 2024:

In the first 6 months of 2025, the Company achieved an after-tax profit of VND 137,6 billion, reflecting a year-on-year increase of VND 32,9 billion or 31,5%. As presented in the written explanation for the first and the second quarters of 2025, the first 6 months of 2025 saw an increase in demand for construction materials for enhanced implementation and the progress acceleration of traffic infrastructure investment projects in the Eastern and Southwestern regions. The Company recorded a growth in revenue from sales of goods, primarily driven by the increased sales volume of construction stone products provided to key projects in the Southeast and Southwest regions. Specifically, the revenue from sales of goods for the first 6 months of 2025 increased by VND 117,8 billion, equivalent to 18,71% over that of the same period of 2024.
