In the Review Report on the mid-year financial statements for the period from January 1 to June 30, 2025, the after-tax profit of Bac Giang Clean Water Joint Stock Company increased by more than 10% compared to the same period in 2024, as shown in the table below:

Reason for the change:

* Net revenue from sales of goods and provision of services in the first half of 2025 increased significantly (approximately VND 11 billion) compared to the same period last year. This increase is due to the fact that, starting in March 2025, the company was authorized by the competent authorities to adjust the water selling price. In addition, the development and expansion of water supply

areas also makes the number of customers at June 30, 2025 of the company more than the same period by about 4.400 customers. These are the main factors driving the strong growth in net revenue.

As a result, the company's after-tax profit in the first half of 2025 increased by VND 2.63 billion, equivalent to a 60.26% increase compared to the same period last year.

The above explains the after-tax profit increase in the Reviewed Financial Statements for the first half of 2025, which rose by over 10% compared to the same period in 2024.
