3. Supervisory Activities of the BOD over the Executive Board:

The Board of Directors (BOD) has earnestly fulfilled its supervisory role over the Executive Board through continuous, timely monitoring. Supervision has been conducted via various forms such as monthly briefings, ad hoc meetings, and communication through digital means (email, Zalo, etc.) as well as telephone calls.

In the context of the ceramic tile market facing significant challenges due to weak demand and unrevived real estate sector, several of the Company's factories had to suspend or reduce production to minimize inventory. In response, the BOD issued strong directives, focusing efforts on enhancing sales capabilities and marketing activities to promote product consumption. At the same time, the Company conducted a comprehensive review of expenditures, reasonably cutting costs, and adjusting investment progress to maintain financial balance.

Thanks to these measures, the Company continued to fulfill its tax obligations to the State, pay mandatory insurance for employees, and settle bank debts on schedule.
